### 34/10 Late Items to be introduced by the Chair

In accordance with Section 100 (B)(4) of the Local Government Act 1972, the Chair agreed to admit the following items on the grounds that they related to events taking place before the next scheduled meeting of the Committee:

### **Relaxation of Licensing Hours for the Royal Wedding**

## 37/10 Cumulative Impact Policy Update

The Environmental Health Manager, Mike Kay, provided an oral update on the request for a Cumulative Impact Policy from Derbyshire Constabulary. Members were advised that as Licensing Committee members as ward Councillors, they would be considering the request from two perspectives and should be mindful not to fetter their discretion. It was noted that there had been few responses to the consultation thus far. Members questioned how the Consultation had been advertised and it was reported that there had been an initial press release, a reminder issued and space on the website used for the consultation. Councillor Skelton reported that there had been general support at the Health and Well Being Board for the policy and that they had intended to put in representations.
