The Conservation Area Advisory Committee received a report detailing the George Rennie Award, Shortlisted Buildings for 2014. The annual award is made by the Committee in memory of the services of the former long standing Conservation Officer for the city, George Rennie.

The Committee make the awards in recognition of the care and skill with which conservation projects and new build projects within conservation areas, completed in the previous 12 months, have been designed and implemented. The buildings short-listed for consideration of being awarded George Rennie Award 2014 were:

- The Magistrates Court, Derwent Street
- No.29 Sadler Gate
- Darley Abbey Stables
- Ashgate School, Ashbourne Road
- Park Bike works, Full Street
- Silk Mill, ground floor works
- Sadler Bridge Studios, Bold Lane

The Committee carefully considered all of the projects and their own individual merits. All contenders were deemed to be of a good standard and met George Rennie's criteria for an award. The Committee wished a vote of thanks be recorded regarding the Conservation Officers input into all the projects that were considered.

- i) the application would have a detrimental impact on the conservation area, in particular the setting of the Grade One listed Cathedral Tower.
- ii) the proposal included increased height in relation to a previously submitted application, which the Committee felt would be overpowering due to:
 - a) the number of windows
 - b) the materials which were being proposed to construct the building
- iii) there was insufficient information provided regarding the plant and equipment housing
- iv) the Committee requested an archaeological condition for a survey to be carried out to be placed on the application.

Darley Abbey Conservation Area

Proposal: Installation of replacement front and back doors and one internal ground floor door together with installation of 3 velux roof lights and internal alterations

Listed Building: GD2

Resolved to raise no objections subject to Conservation Officers approving the reduction of the number of roof lights to two and recommended that metal roof lights would be more appropriate.

Proposal: Single storey side extension to dwelling house (study, lobby and w.c)

- ii) a full archaeological statement and evaluation would be required with possibly a condition being put on the application
- iii) as the application would be in situated within a World Heritage Site appropriate screening would be required to obscure any clutter.

- iii) the proposed materials were inappropriate
- iv) the application was overbearing and would produce too much massing on the site
