4.1 Additional Adult Social Care Funding : Autumn Budget

The Autumn Budget on 29 October 2018 announced extra one off funding for Winter pressures in Adult Social Care. This funding is paid to local authorities to support the local health and social care system to manage demand pressures for the winter 2018/2019. Derby's share of this is £1,148,569. Although this additional funding is welcomed, this is a temporary one year measure that will not altogether alleviate the wider permanent pressures for social care.

4.2 It is recommended to approve the £1,148,569 one off funding be used to help alleviate the Winter pressures in Adult Social Care and to delegate authority for allocating the use of this funding to the Strategic Director of People Services in consultation with the Section 151 officer and the relevant cabinet member.
