# Application for a new premises licence at: Derventio Brewery Darley Abbey Mills Darley Abbey Derby DE22 1DZ

#### **SUMMARY**

- 1.1 An application for a new Premises Licence at Derventio Brewery Darley Abbey Mills Darley Abbey Derby DE22 1DZ has been received by Derby City Council's Licensing Team.
- 1.2 The sale by retail of alcohol; the supply of alcohol by or on behalf of a club to A member of the club; the provision of regulated entertainment; and the provision of late night refreshment must be licensed under the Licensing Act 2003.
- 1.3 Officers have delegated powers to deal with new Premises Licenses applications where there are no Relevant Representations received; however this is not the case with this application and hence attendance at committee today.
- 1.4 The General Licensing Sub Committee can decide to:
  - grant the application subject to conditions consistent with the operating schedule accompanying the application, modified to such an extent as the authority considers necessary for the promotion of the licensing objectives,
  - grant the application subject to any conditions which must under section 19,
     20 or 21 be included in the licence.
  - grant the application subject to the exclusion of any licensable activities to which the application relates,
  - grant the application but refuse to specify a person in the licence as the Premises Supervisor,

or

reject the application.

#### **RECOMMENDATION**

2.1 To consider the information in the report, consider the application and any Relevant Representations to determine the application for a new Premises Licence at:

3.1 To ensure that the four licensing objectives are upheld in relation to the application for a new Premises Licence at: Derventio Brewery Darley Abbey Mills Darley Abbey Derby DE22 1DZ.

## SUPPORTING INFORMATION

- 4.1 An application for a new Premises Licence was received by Derby City Council's Licensing Team from John Baldock and Peter Nash on 14 January 2014. A copy is attached at **Appendix 2.**
- 4.2 The Licensing Team has received 4 Relevant Representations, from Other Person(s). 2 of these relevant representations are identical in content but have been submitted by 2 separate individuals. These are attached at **Appendix 3**.
- 4.3 Derbyshire Constabulary have agreed conditions in relation to the application. A schedule of conditions received by Derby City Council Licensing Team on 06 February 2014 has been attached at **Appendix 4**.
- 4.4 The responses from all Responsible Authorities are detailed in the table below;

- 4.5 The licensable activities applied for are:
  - the sale by retail of alcohol (off and on the premises)
  - Regulated Entertainment; (indoors and outdoors) a performance of live music, any playing of recorded music, entertainment of a similar descriptions to that falling within the performance of live music and the playing of recorded music
  - The provision of late night refreshment
- 4.6 The days and times of the licensable activities applied for are:

Supply of alcohol for consumption - Sunday to Saturday 08:00 – 23:00 Live and Recorded music – Monday to Friday 18:00 – 23:00 Saturday 11:00 – 23:00

Sunday 11:00 – 22:30

Provision of late night refreshment - Monday to Thursday 11:00 – 23:00 Friday and Saturday 11:00 – 24:00 Sunday 11:00 – 23:00

4.7 The days and times the premises are open to the public are:

Sunday to Saturday 08:00 – 23:00

Seasonal Variations – Christmas Day, Boxing Day, New Year's Day Closed

- 4.8 The Proposed Premises Licence Holder is: John Baldock and Peter Nash
- 4.9 **The Proposed Designated Premises Supervisor is:** John Baldock
- 4.10 A location plan of the premises is attached at **Appendix 5**
- 4.11 The Committee is obliged to determine this application with a view to promoting the

licensing objectives which are:

- the prevention of crime and disorder;
- public safety;
- the prevention of public nuisance;
- the protection of children from harm.
- 4.12 In making its decision, the Committee is also obliged to have regard to national Guidance issued under Section 182 of the Licensing Act 2003 and the

Council's

own Licensing Policy.

- 4.13 The Council recognises the importance of securing proper integration with and attaching relevant conditions that reflect local strategies.
- 4.14 The Council has a duty to act in a manner which is compatible with the Human Rights Act 1998.

4.15 A Licence is regarded as property for the purposes of the Human Rights Act 1998. Article 1 of the First Protocol states that:

"Every natural or legal person is entitled to the peaceful enjoyment of his possessions. No one shall be deprived of his possessions except in the public interest and subject to the conditions provided for by law and by the general principles of international law.

The preceding provisions shall not, however, in any way impair the right of a State to

enforce such laws as it deems necessary to control the use of property in accordance with the general interest or to secure the payment of taxes or other contributions or penalties."

4.16 The Committee must also take into account the effect on local residents.

Article 8

#### states:

- Everyone has the right to respect for his private and family life, his home and his correspondence.
- There shall be no interference by a public authority with the exercise of this right except such as is in accordance with the law and is necessary in a democratic society in the interests of national security, public safety or the economic well-being of the country, for the prevention of disorder or crime, for the protection of health or morals, or for the protection of the rights and freedoms of others.
- 4.17 Three stage test to be applied:
  - Is the interference in accordance with the law?
  - Is the interference necessary in a democratic society in pursuit of one of the legitimate aims set out above?

Is the decision proportionate ie. Striking a fair balance between the demands of the general interests of the community and the requirement to protect the individual's fundamental rights?
