



## Urgent Non-Executive Decisions Made by the Chief Executive

### SUMMARY

1. This report asks the Council to note the urgent non-executive decisions taken by the Chief Executive, in consultation with the political group leaders, since the last meeting of the Council.

### RECOMMENDATION

2. To note the decision of the Chief Executive, in consultation with the political group leaders, to appoint Councillor Troup as Chair of the Neighbourhoods Commission, in place of Councillor Batey, for the remainder of the current municipal year.

### REASONS FOR RECOMMENDATION

3. Councillor Batey's work commitments have increased following his appointment as Chair of the Neighbourhoods Commission at the Annual Meeting. The Liberal Democrat Group nominated Councillor Troup as his replacement.

### SUPPORTING INFORMATION

- 4.1 In the Council's Constitution the Chief Executive has delegated authority to make decisions on behalf of the Council, in cases of urgency, in the discharge of any non-executive function of the Council other than those delegated to another officer or those which by law can be discharged only by full Council. The Chief Executive always consults, and seeks the agreement of, the political group leaders on proposed decisions.
- 4.2 This report advises Council of the following decision taken by the Chief Executive in accordance with this delegated authority:
- 4.3 **Appointment of Chair of the Neighbourhoods Commission**  
To appoint Councillor Troup as Chair of the Neighbourhoods Commission in place of Councillor Batey for the remainder of the current municipal year.

**Reason for Urgency:** A meeting of the Neighbourhoods Commission was scheduled and a new Chair needed to be appointed.
