At approximately 13:25 hours on Sunday 8<sup>III</sup> December 2019 police were called to an address on Uttoxeter New Road, Derby were a male had been the victim of an assault involving a weapon and subsequently received life threatening injuries. The victim is currently in hospital in a critical condition as a result of his injuries.

Through the police investigation, it has transpired that there is a causal link to the Premier Rowditch store, 211-213 Uttoxeter New Road, Derby however the details cannot currently be disclosed due to this being an ongoing criminal investigation.

CCTV was requested from the premises however this was not fulfilled as per the premises licence conditions. Due to the particulars of the case it is the opinion of the licensing team that we have lost confidence in the Premises Licence Holder and Designated Premises Supervisor

It is the view of the police that this incident has triggered an application for an expedited review under Section 53A of the Licensing Act 2003.

The police therefore kindly request that the Licensing Authority uses its powers to suspend the licence until such a time that a full review can take place and to give the police and Licensing Authority the assurance that the Licensing Objectives will be fully promoted. The police feel that at the present time to only action from the review is the consideration of revocation of the Premises Licence.

Whilst making this application I would ask the panel to consider regulation 14 of the Licensing Act 2003 (Hearings) Regulations. I would request that the authority takes the view that the public interest in excluding the public from this hearing, out ways the public interest in the hearing, taking place in public.

I would ask that all members of the public are excluded, except for the Premises Licence Holder;

To clarify, the police are bringing forward matters that are part of ongoing criminal investigations which could be prejudiced by public disclosure of the facts.

Whilst making this application and signing the certificate, I have considered the following;

The home office states that the test to determine the kinds of conduct that amounts to serious crime are set out in section 81 (2) and (3)(a) and (b) of the regulation of investigatory powers act 2000. Those tests are that the conduct;

- (a) Constitutes at offence for which a person who is 21 years of age or over with no previous convictions could reasonably be expected to be sentenced to imprisonment of 3 years or more
- (b) Involves the use of violence, results in substantial financial gain or is conduct by a large number of persons in pursuit of a common purpose.

Alternative powers have been considered under the Licensing Act to address the issues but they have not been deemed suitable. These powers would be Section 19 which cannot be used for an off licence and section 51.

To reiterate the Chief Officer of Police is therefore of the opinion that the suspension of the Premises License pending the full Licensing Review (53c) is appropriate, proportionate and reasonable. The action taken is in line with the licensing objectives of the prevention of crime.
