Joined Up Care Derbyshire Update - development of the Derbyshire Integrated Care System (ICS)

Purpose

1.1 This report provides an update from Joined Up Care Derbyshire (JUCD).

Recommendation

2.1 To note the update from JUCD.

Reason

3.1 To ensure that the Health and Wellbeing Board is informed of, and engaged with, JUCD, ensuring alignment and joint effort as necessary on shared priorities.

Supporting information

- 4.1 JUCD continues its progress in the development of Derbyshire's Integrated Care System (ICS).
- 4.2 The <u>Health and Care Bill</u> introduced in Parliament on 6 July 2021 confirmed the Government's intentions to introduce statutory arrangements for integrated care systems (ICSs) from April 2022. Subject to legislation being agreed each ICS will comprise an:
 - Integrated Care Partnership (ICP): the broad alliance of organisations and representatives concerned with improving the care, health and wellbeing of the population, jointly convened by local authorities and the NHS.
 - Integrated Care Board (ICB) bringing the NHS together locally to improve population health and care.
- 4.3 In Derbyshire we intend that these new structures will build on, rather than replace, the partnerships that have developed over many years across our system.

- 4.4 Other important components within the ICS are Provider Collaboratives and Place partnerships.
 - Place-based partnerships are collaborative arrangements formed by the
 organisations responsible for arranging and delivering health and care services
 in a locality or community. It is intended that there will be two Place
 partnerships: one for the city, one for the county.
 - Provider collaboratives are partnership arrangements involving at least two trusts working at scale across multiple places, with a shared purpose and effective decision-making arrangements.
- 4.5 Work is ongoing to shape what the ICS will look like in Derbyshire including a range of public and partner engagement. The document, Developing Derbyshire's Integrated Care System, circulated to stakeholders is attached for information.
- 4.6 More information on Derbyshire's Integrated Care System can be found by accessing: https://derbyshireinvolvement.co.uk/integratedcaresystem. This includes virtual engagement sessions and the opportunity to contribute ideas to its development and improvement.
- 4.7 The roles and functions of the ICS are broadly set out in national guidance documents. There remains, however, local flexibility in the implementation of ICBs and ICPs. JUCD was required to submit a proposal as to how it intends to implement an ICB and ICP in Derbyshire to NHS England by 17 November 2021.
- 4.8 JUCD publishes bi-monthly newsletters which provide news and updates on ICS development, initiatives such as Team Up Derbyshire a programme intended to transform the way health and care services are provided to housebound patients across the city and county partnership approaches to delivery of community care, Place Partnerships and the Derbyshire Shared Care Record (DSCR). - 5.4 JUCD has established a Patient and Public Insight Library to collect, organise and collate insight gathered across all system partners in Derbyshire.
