## **ELECTION PAYMENTS – 2012 LOCAL ELECTION**

#### **SUMMARY**

- 1.1 Elections will take place in all seventeen of the City's wards on 3 May 2012.
- 1.2 Successful delivery of the election requires a significant amount of work over and above the day-to-day operations of the Council. This is achieved, by a balance of Council employees and temporary appointments.
- 1.3 Those who perform election duties outside their normal hours, or who are employed on temporary contracts, are paid at a rate commensurate with the hours worked and their levels of responsibilities.
- 1.4 The Electoral Commission good practice guidelines, recommends local authorities publish their schedule of election payments and the Localism Act requires it for senior officers.
- 1.5 Benchmarking with comparator authorities and calculation of numbers employed and rates paid, enable costs to be contained within budget headings

#### RECOMMENDATION

2.1 To approve the schedule of fees as set out in Appendix 2

### REASONS FOR RECOMMENDATION

- 3.1 To comply with requirements of the Localism Act 2011 and Electoral Commission good practice guidelines.
- 3.2 To improve openness and transparency.
- 3.3 To enable recruitment to posts to begin, with established rates of pay.

4.1 The schedule, attached at appendix 2, gives a comprehensive breakdown of the type, number and rates of pay for all roles required for the efficient delivery of the election.
