Report of the Chief Executive Officer, Derbyshire CCGs

Collaborative Working Across the City and County and the Role of Clinical Commissioning Groups

SUMMARY

- 1.1 I am the newly appointed Chief Executive Officer working across the four Derbyshire Clinical Commissioning Groups (CCGs). One of my immediate priorities is to listen to the thoughts of the people with whom we work, to see how we can continue to transform health and care services for our residents and to listen to what matters most to our staff and partners.
- 1.2 As a starter, I would like to better understand everyone's thoughts on collaborative working across the county and the role the CCGs need to play in helping to take our commissioning agenda forward. My intention is to understand the consensus view to inform our collective commissioning thought for the future.
- 1.3 I am particularly interested in your views on the following:
 - How we can better understand and maximise the opportunities we have in collaborating between the CCG and our main stakeholders across Derbyshire.
 - What are the challenges to collaborative working?
 - What can we do to ensure productive relationships?
 - What do we need to help improve opportunities for collaboration?
 - What are the opportunities and risks to the four CCGs working more closely together?
 - At what footprint(s) is it most effective to commission different services?
 - What role do you think commissioners should play in the local health and care system?
- 1.4 The Joint Derby and Derbyshire Health and Wellbeing Board held last month demonstrated that we have a willingness to work together as a system but also that we have some way to go to do this effectively. A good debate and constructive challenge on how we work collaboratively and productively together is a positive step on this journey and ensuring that NHS commissioners are an effective partner.

RECOMMENDATION

2.1 To actively contribute to collaborative working across Derbyshire and the role the CCGs will need to play in helping to take our commissioning agenda forward.

- 3.2 To support the HWB in its responsibility to have a joined up approach to health and social care to meet the needs of the local population
