Manager's comments: I would like to expand the service and employ another worker. The needs of a culturally sensitive service mean that one member of staff is unable to observe all attenders because they are spread through the building

Summary And Recommendations

The service shows evidence of meeting the service level agreement or of working towards it. The luncheon club is meeting service level agreements in respect of the numbers of places in use each week. Attendance is slightly above the specified requirements at 23.75 places a week. This represents an improved unit cost, reducing from £28.43 per person per week to £23.94 a week taking the inflationary uplift into account.

There is still work to do to complete the care plans. A risk assessment and management system needs to be put in place. Activities are taking place but as yet no evidence of live entertainment or talks on health issues since the formal commencement of the service. From discussion with users there is evidence that they value the service. There is evidence that independence is valued and promoted.

There has been some progress in training the staff but this needs following through to ensure minimum standards of Moving and Handling and Food Hygiene are adhered to. The evaluators recognise that the service is still in its early stages.

Recommendations

The funding should continue for a further six months until October 2004.

Hadhari should complete the training requirements for care and catering staff by that time.

Further work to be undertaken to complete and date the outstanding care plans and review existing plans.

Hadhari should continue to reduce the unit cost of the service by increasing the numbers attending and/or reducing the running costs

Hadhari should review its activity programme to meet the requirements of the service specification.

Hadhari should work with Whitaker Road Day Centre to develop a formal risk assessment and management procedure.

A further review should take place in April 2004 to audit compliance with these recommendations.
