## 62/06 Petitions

#### To consider responses to petitions received

#### a) Traffic Management Petition St Alban's Road

The Panel considered a report from the Cabinet Member for Planning and Transportation that detailed a response to a petition received in September 2006 from residents of St Alban's Road which asked the Council to consider taking a number of actions regarding the speed and volume of traffic on St Alban's Road and the dangerous junction of Manor Road and St Alban's Road as detailed in the report.

#### b) Parking on Church Street, Normanton

The Panel considered a report from the Cabinet Member for Planning and Transportation that detailed a response to a petition regarding new double yellow lines in a previously unmarked area, which was regularly used by residents to park their cars over many years. The petition suggested the option of parking permits for residents of Church Street.

It was proposed to remove all the yellow lines in front of the residential properties meaning around 9 additional parking spaces would become available without compromising turning manoeuvres unduly in the turning head.

# 66/06 Public Question Time

The following issues were raised by members of the public:

#### Recycling

A member of the public asked what the timetable was for rolling out the recycling scheme to the rest of the city. A member of the public asked that the Council apply more pressure to ensure that **ALL** areas of the city have a domestic recycling bin.

Councillor Williamson responded that he understood it to be within the next 12 – 18 months but would confirm that in the next meetings updates.

#### Semi-derelict and derelict buildings

A member of the public asked what was to happen to buildings that were semiderelict or derelict and were therefore bringing down the tone of an area. She asked whether any properties had been served with Compulsory Purchase Orders. The resident asked to be advised on what is to happen in order to improve the 'visual amenity' of the neighbourhoods. In particular, Leopold Street, Dashwood Street and Mount Carmel Street. The resident referred to section 215 of the 1990 Town and Country Planning Act which gives powers to local authorities to address the problems of derelict and empty properties and why is the Council not making more use of these powers.

Councillor Williamson responded that a Compulsory Purchase Order had been

used on a property on Stockbrook Street, and that he had raised the issue with officers to ensure the Council is more proactive in this matter.

Councillor Nath reported that he received a list of empty and derelict properties each month to consider how to deal with them. Some properties were in dispute, where the owners can't be traced or the property is tied up in probate.

# Agreed to receive a list of empty and derelict houses with their current status within Area Panel 3 at the next meeting

#### Newspaper collection

A resident reported that the Newspaper collection service in his area had stopped four weeks before and asked for it to be returned.

Councillor Williamson responded that he would look into the situation and respond directly to the resident.

#### **Pollution and Severance – Connecting Derby**

A resident asked whether the Council planned to tell local residents about disruptions to their lives when Connecting Derby cuts through their communities. He was particularly concerned about residents suddenly having a large road outside their front doors and cutting through the middle of communities, effectively splitting them into two.

Agreed to receive a response at the next meeting

#### **Cycling Improvements in Area Panel 3**

A resident stated that City Council claims at the forthcoming public inquiry (17.4.07) that massive new construction/demolition in Abbey ward will provide improvements for cycling. Please explain in detail with evidence at this Area Panel 3 meeting.

Councillor Williamson responded that he did not have the information to hand and agreed to provide a response to the resident.
