

1) Background

This paper presents Derby City Council's proposals for the use of Department of Health funding for 2013-14 which Local Area Teams must transfer to Local Authorities to spend on agreed social care services which benefit the whole system.

The funding (£4,110,920) is deployed to underpin five areas of existing social care service provision which supports the whole health and care system.

Intermediate care at Perth House. Funding Code 52131020	Perth House provides a 16 bed- based intermediate care service for Derby. The service is available for all people who are well enough to be discharged from hospital but not well enough to return home, and people who are not well enough to stay at home but don't need hospital care. A mix of social care and nursing staff are available at the facility.
