# SCHOOLS CAPITAL PROGRAMME 2011/12

## SUMMARY

- 1.1 The Council's capital programme has allocated funding of £5,250,000 for school capital projects in 2011/12. This has been prioritised in line with the priorities set out in the Schools Asset Management Plan 2010-12.
- 1.2 Future funding will mainly be directed at dealing with essential condition issues and basic need - providing additional school places where necessary.
- 1.3 The schools capital programme priority schemes for 2011/12 primarily fall into one of three categories – fire precaution work. Buildings at Risk issues and mechanical projects.

## RECOMMENDATION

- 2.1 To approve the Schools Capital Programme priority schemes for 2011/12.
- 2.2 To approve Capital Scheme Commencements for the individual schemes included in this report.

## **REASONS FOR RECOMMENDATION**

- 3.1 An ongoing programme of work is required in school premises to deal with essential condition issues and to provide additional school places.
- 3.2 Work is necessary to ensure that school buildings are safe and remain open. The Local Authority also has a statutory requirement to provide sufficient school places.

## SUPPORTING INFORMATION

- 4.1 The Government has committed to reducing the national budget deficit, and as a result there will be a scaling back of most planned capital programmes. Derby will only receive Building Schools for the Future BSF funding for three schools and there will be no further Primary Capital Programme PCP investment. The recently announced Comprehensive Spending Review covering the next four years indicated as much as a 60% reduction in school capital funding.
- 4.2 On future capital funding for schools, the Sebastian James review of the Department for Education's DfE capital programmes will announce its findings in 2011, and its recommendations will inform the allocation of capital from 2012/13. (There are indications that Lees Brook Community Sports College may be used as a case study in the Sebastian James Review). The information in DfE statements indicates that the headline annual amounts of funding for basic need / additional school places and maintenance for 2012/13 to 2013/14 will be in line with the amounts announced for 2011/12. However, the methodology of allocation and management of future years' funding may change with the recommendations of the national capital review.
- 4.3 The DfE capital statement acknowledges that there are schools in need of refurbishment that have missed out on national capital programmes. However, there is no indication of a funding stream for significant rebuild or refurbishment projects in 2011/12. There are unlikely to be any further DfE announcements on future capital spending until after the national education capital spending review reports its findings in 2011.
- 4.4 Future capital funding will be mainly directed at two issues: dealing with essential condition issues and basic need, i.e. providing additional school places.
- 4.5 Another major change is the significant reduction in schools' devolved capital funding. The 2011/12 allocation is £901,634 (including VA schools), compared to £4,786,990 for 2010/11. This funding provides each school with its own capital money to address school priorities, including new buildings, capital repairs and refurbishment and ICT, in accordance with priorities set by each school and in line with the local school Asset Management Plan.
- 4.6 There is also no ring fenced Schools Access Initiative Funding SAI for 2011/12. In previous years, Derby has received an annual allocation of £505,280 for SAI funding. Some funding will need to be allocated for disabled access improvements, or for specialist equipment, from Derby's Schools Capital Allocation for 2011/12.
- 4.7 Despite recent investment, there remains a significant backlog of condition issues across the primary, secondary and special school estate, which is well in excess of £58 million. This condition backlog only covers building condition issues and excludes costs associated with betterment, asbestos identification/removal, work identified as a result of fire risk assessments, any water hygiene remedial work or any work related to mechanical (heating and boilers) and electrical elements.

- 4.8 The Schools Asset Management Plan for 2010 -12 outlined the following key priorities:
  - Fire precaution works highest priority work arising from fire risk assessments carried out under the Regulatory Reform (Fire Safety) Order
  - Renewing life expired boilers and heating systems
  - Upgrading electrical installations
  - Upgrading fire alarms and emergency lighting
  - Replacement windows
  - Re-roofing
  - Structural repairs
  - Security and safeguarding issues
  - Other relevant health and safety issues, such as asbestos
  - Basic Need additional school places
- 4.9 The Council's capital programme has allocated funding for £5,250,000 for school capital projects in 2011/12. The allocations for 2012 /13 and 2013/14 are £5,250,000, so the overall three year allocation is £15,750,000. This funding and phasing is shown in more detail in Appendix 2. There is a corporate contingency from which further school capital projects may also be prioritised.
- 4.10 The Council has also received an allocation of £568,000 LEA Co-ordinated Voluntary Aided Programme LCVAP funding for 2011/12 for capital schemes at voluntary aided schools. The proposed LCVAP projects for 2011/12 are shown in Appendix 3.
- 4.11 Due to the lower levels of funding in view of BSF and PCP funding being stopped, priorities are likely to be limited to ensuring that buildings are safe by addressing urgent health and safety issues and dealing with Buildings at Risk issues. The LA also has a statutory responsibility to provide sufficient school places.
- 4.12 The schools capital programme priority schemes for 2011/12 primarily fall into one of three categories fire precaution work, Buildings at Risk issues and mechanical projects. The proposed projects for 2011/12 are shown in Appendix 3, which summarises the categories of work and budget estimates, subject to detailed feasibilities and the usual tendering process. These priority schemes have also been discussed with head teachers and school representatives on the Schools Asset Management Improvement Group.
- 4.13 A range of proposed school capital projects are shown in Appendix 3. The largest single scheme is for £2,000,000 in 2011/12 to address urgent condition and Health and Safety issues at Lees Brook Community Sports College. There is also a major scheme proposed for Homefields Primary School for £1,600,000 to expand the school from 210 places to 315 places from September 2013. The proposal is to partially fund this scheme with £600,000 from the 2011/12 capital funding allocation, together with a further £1,000,000 from the proposed 2012/13 capital funding allocation.

## OTHER OPTIONS CONSIDERED

5.1 No other options have been considered. The available funding has been prioritised in line with the Schools Asset Management Plan to deal with the most urgent condition issues and to ensure the Local Authority meets its statutory obligation to provide sufficient school places.
