CLA accessing education from the children's homes <u>Information from Pauline Inwood as at 23rd August 2007:</u>

Here is the round-up regarding education for LAC in the Homes, as known at 23 August, and expected to be the case at the start of term

Total LAC in the Homes (from placement schedule of 16/8/07) - 35

School age LAC in the Homes - 26 - as -

16 have Full-time timetables, 11 of these on mainstream (including Special) school rolls, 5 in the PRU

9 have part-time timetables, 7 of these on mainstream (including Special) school rolls, 2 in the PRU

1 child with a statement has no school place at present - Richie D'Eon

10 have statements of Special Educational Needs, 2 of these in Special School

Of the 4 who were highlighted as of special concern in the May list, 3 are now in education placements
The fourth, from foster care, recently moved to another authority and may be without a school place at the start of term - **Bethany Titterton**

The two highlighted names are currently specific concerns with regard to school placement.

Number of cautions and convictions (aged 10yrs plus):

- 10 out of 184 children offended (5.4%) during 1 Oct 2006 and 31 July 2007
- 3 out of the 10 children have offended more than once. (James Martin has offended 3 times, Tamara Selby twice and Katrina Seal twice.
- Health of CLA (looked after for 12 months or more): 1 Oct 2005 and 30 Sept 2006
- Out of 289 children looked after for 1 year or more, 263 had a dental check and 251 an annual health assessment.
- This information will be updated during October as it will be collected in the 2007 OC2 return.
- Stability of placements of CLA- the definition is:

The percentage of children looked after at 31 March with three or more placements during the year

- The most recent figure as at 31July 2007 was 10.1%, the target for 2007/08 is 9.5%
- The out turn figure at year end 31 March 2007 was 10.7%, with a target for 2006/07 of 9%
- \bullet The 2005/06 figure for Derby was 9% , the 2004/05 figure was 8.4%
- Comparator authority figure for 05/06 was 12.4%

• Employment, education and training for care leavers- the definition is:

The ratio of the percentage of CLA on 1 April in their 17th year (aged 16) who were engaged in education, training or employment at the age of 19 to the percentage of young people in the population who were engaged in education training or employment at the age of 19

- The most recent figure as at 31 July 2007 was 100% (9 out of 9 cases) which compared to the population within that age group (81%) results in a ratio of 1: 1.23
- The out turn figure for 31 march 2007 was 80% (32 out of 40 cases) which compared to the population within that age group (81%) results in a ratio of 1: 0.99
- The out turn figure for 31 march 2006 was 84% (21 out of 25 cases) which compared to the population within that age group (81%) results in a ratio of 1:1.04
- Comparator authority figure for 05/06 was 1:0.
- Derby 2003/04 figure was 1:1.16
- Comparator authority figure for 2003/04 was 1:1
