Area Panel Budget Proposals 2005/6

#### SUPPORTING INFORMATION

- 1.1 The Area Panel 5 budget allocation for 2005/6 is £22,000. The Panel has an additional budget of £11,050 carried forward from 2004/5, which means that a total budget of £33,050 is available for allocation to projects during this financial year.
- 1.2 The Panel is asked to consider six applications for funding received from:

- 1.6 The Council Constitution states that the Area Panels can 'use a delegated budget for local environmental and community purposes'. Therefore, if an application does not specifically refer to a local activity, consideration needs to be given to the appropriateness of allocating area panel funding to the project. In deciding whether to support each application, the area panel will assess the funding request against the funding criteria and its priorities.
- 1.7 The new funding criteria, included in the Council Constitution, says that applications need to provide a service in response to the needs of local residents and meet at least one of the following criteria:
  - improve access for local people to existing services
  - provide a service in response to an issue raised in a community update report
  - contribute to improvements which will provide a benefit to local residents
  - assist in providing an integrated service in response to an issue raised at an area panel meeting
  - enable residents to participate in their community or at area panel meetings.

#### Applications also need to:

- provide evidence of need for the application
- show evidence that ongoing maintenance or revenue costs have been approved by the relevant Council department, if necessary.
- 1.8 The priorities for supporting an application are that it:
  - is from a voluntary or community group
  - shows evidence of match funding or self help
  - provides a service in response to the needs of local residents
  - will directly benefit people living in the geographical area covered by the area panel
  - show evidence of how the project will be sustained beyond the period of funding, if it is not a one-off project
  - contributes to the delivery of one or more of the Council's corporate objectives.
- 1.9 In most circumstances, the amount of funding that the area panel will award to an applicant will be between £50 and £2,000. However, the area panel does have the discretion to award more if it considers the application to be a priority for the area.

#### **IMPLICATIONS**

#### **Financial**

1.1 Area Panels must consider priorities within the Area when considering requests for funding. Not all requests that meet the criteria will be considered a priority. When supporting or rejecting an application over £25,000, the Panel must give reasons for its decision.

#### Legal

- 2.1 The Area Panel has delegated authority to use its budget for local environmental and community purposes.
- 2.2 Section 19 of the Local Government (Miscellaneous Provisions) Act 1976 empowers the Council to offer grants to voluntary and other organisations to provide any recreational facilities.
- 2.3 Any decision involving the making of a grant or loan over £25,000 to any voluntary body is deemed to have a significant impact on two or more wards and is therefore a key decision.
- 2.4 After a key decision has been taken, the Director of Corporate Services must publish a record of every executive decision taken at that meeting within two days of that meeting. The record must include a statement of the reasons for each decision and any alternative options considered or rejected at the meeting. No action will be taken on any such decision for five clear days from the date of publication.

Appendix 2

**Applicant 1:** 35<sup>th</sup> Derby (Markeaton) Scout Group

**Project:** Security fencing

Total cost of project: £2,202

Amount of funding requested: £1,950

Wards: Darley

#### **Description:**

The group was founded in 1914 and occupies over half an acre that includes the Group Headquarters and an area for games on Watson Street. The group comprises Beavers, Cubs, Scouts and Explorer Scouts totalling about 80 members. There is also a Brownie and Guide group that use the building. The majority of the membership comes from the local area including the 'West End'. Other organisations use the building including the Youth Hostels Association as well as private parties. Overnight stays in the grounds are also arranged. The group depends entirely on fundraising by its members including a Summer fayre and Bonfire night.

This project is to erect security fencing to prevent trespassers and vandals from entering the grounds. In recent times the group has suffered loss of equipment and damage to property caused by intruders. The previous fence has now decayed and no longer serves its purpose. The new fence would also offer more protection for allotment holders on the Ashbourne Road and District Allotments Association on Mackworth Road who have also suffered loss and damage caused by vandals.

The funding will pay for 34 metres of low maintenance galvanized steel palisade fencing. Once erected the group would maintain the fence. The group will be providing the remaining £250 funding either from a loan from the groups mini-bus fund or loans from group members.

The fencing is regarded as one of the group's priorities to improve safety and protection of equipment. The work would commence as soon as funding is available.

Area Panel 5 allocated the group £1,729 in July 2003 for repairs to the scout hut.

**Applicant 2:** Little Chester Residents Association

**Project:** Keeping the community in touch

**Total cost of project:** Approximately £2,000

Amount of funding requested: £750

Wards: Darley

#### **Description:**

The group was set up in July 2004 to represent the interests of residents of the Chester Green area. They represent over 1,000 households in the area. They have a number of aims including to preserve the historic features in the area, enhance the amenities and maintain the environment.

The group communicate with their membership using newsletters, public meetings and through their website that includes information on local services, amenities, education and entertainment with local news updates and links to various businesses and organizations who support them.

The group wish to continue connecting the local community by means of a regular newsletter. Currently they print 1000 copies of a 16 page A5 sized newsletter. They believe there is demand for the service and have provided a newsletter over the last year in the Chester Green area. They believe they have made a difference within the Chester Green area with both residents and other local organisations and want to continue the newsletter.

This project is to fund four issues of the newsletter in March, June, September and December 2006. Their best quote is £480 for one issue giving a total cost of about £2,000 for the four issues. This request is for £750 as a contribution towards the printing costs.

The group will raise the remaining £1,250. They have already secured £100 sponsorship and are actively seeking funds from the Community Chest and other local business and organizations. They hope to raise a further £350 through local fund raising events in the community.

The group received £500 for start up costs from Area Panel 5 in February 2005.

**Applicant 3:** Mackworth Estate Community Association

**Project:** Half-Term Activities and Dance Group

Total cost of project: Over £2,000

Amount of funding requested: £1,200

Wards: Mackworth

#### **Description:**

Mackworth Estate Community Association – MECA, was set up in 2003 to improve facilities and opportunities for people living on the Mackworth estate. MECA has set up a number of initiatives and groups that have become sustainable on the estate.

MECA are holding its fourth Half term activity week for local young people. The first half term activity week was in February 2005 and it has proved very successful with the number of young people attending going up from 20 to over 200 in October 2005. MECA have worked with a variety of partners including Derby College, Sporting Futures and the Council Sports Development Team to put on these events.

In the February 2006 half term MECA will provide a variety of activities for local young people around the Derby College campus including:

- Football with Sporting futures
- Hockey, table tennis, badminton and basketball with Derby College
- Cricket with Derbyshire Cricket Club

This project is requesting funding of £225 to pay for the hire of Derby College facilities and £375 for the Extreme Sports activity, a total of £600.

To make sure the activities are well attended they are all provided free of charge. Derby College is providing all the tutors and coaches except for the Extreme Wheels activity.

In addition to the half term sporting activities, MECA is establishing the Mackworth Estate Junior Dance Group to provide much needed Dance Classes for local young people from 4 years to 14 years. The members each pay £1 a week and train at Mackworth Community Association centre. This application is to fund a dance tutor from Tiptoe School of Performing Arts for 25 weeks at a cost of £375 and the hire of the hall for 25 weeks at a cost of £225.

Once the group is established they hope to become self funding by paying membership fees and organising shows.

MECA believe that providing these activities anti-social behaviour and minor crimes decrease by up to 60% to 70%.

Applicant 4: Mackworth St. Francis FC

Project: Goal Posts

Total cost of project: £520

Amount of funding requested: £520

Wards: Mackworth

#### **Description:**

Mackworth St. Francis FC was set up in 2005 working with Mackworth Estate Community Association. It has now developed into a successful independent local football team.

The success of the drainage work carried out on Knightsbridge Recreation Ground will allow the club to use the football pitch for training for their members. However to achieve this they need some portable easy to assemble and dismantle goals. They will allow up to four teams to train at the same time and will also enable the club to run small 5-a-side tournaments.

This funding request is to purchase two sets of heavy duty polypropylene goals that can be easily assembled and dismantled.

Area Panel 5 allocated £600 to Mackworth St. Francis FC in April 2005 for their under 8s football team.

**Applicant 5:** 3<sup>rd</sup> Derby Boys' Brigade Company

**Project:** Sports/Games Equipment

Total cost of project: £1991

Amount of funding requested: £1991

Wards: Mackworth

#### **Description:**

The 3<sup>rd</sup> Derby Boys' Brigade Company was set up in 1957 and is based on Enfield Road. They have 70 junior members and 10 staff helpers.

The members aged from 5 to 18 regularly use the equipment belonging to the Boys' Brigade. The group provides an extensive range of exciting, challenging and enjoyable activities aiding the development of the young people. Much of the existing games and sports equipment is likely to be withdrawn from use soon on health and safety grounds. The group has a number of members with special needs including several with behavioural problems. It is especially important to consider these members when offering an attractive and interesting programme that can help to keep them engaged.

This project will fund new sports and games equipment to ensure all activities offer minimal levels of risk and would be safe.

The group will repair, maintain and replace the new equipment that will be specifically designed for group use with low wear and tear to minimise costs.

**Applicant 6:** British Legion - Allestree

**Project:** Installation of Disabled People's ramp

Total cost of project: £8,000

Amount of funding requested: £5,000

Wards: Allestree

#### **Description:**

The Royal British Legion Allestree Club was established in 1933 and has about 400 members with the vast majority coming from the Area Panel 5 area. Most of the members live in Allestree ward with some coming from Darley ward. It is an open group and they hire out their facilities to other organisations and for parties.

This project is to improve the walking and disabled people's access to the premises. They aim to provide wheelchair and scooter access by installing a ramp. Currently access for people using wheelchairs is up a couple of steps along a ramp used for deliveries that then goes through a bottle shed and into the premises. Working with the Council Access Officer, Mick Watts they have agreed this as a temporary route with signs and a bell.

The original proposal to install a fixed ramp is not possible because of the location of the drains and the need for permanent access to them. The alternative is a more expensive portable ramp up to a large standing area.

The group have engaged an architect and will be applying for planning permission. The first quote estimates the cost at £7,000 with about £1,000 for planning and architect fees.

The Legion is contributing £3,000 to the project to pay for the planning and architect fees as well as a contribution towards the ramp costs. They previously made an application for funding to the Lottery but were unsuccessful.

#### Suggested recommendation from the Area Panel Grant Appraisal Panel

Approve. The Appraisal Panel noted that the application is for more than the £2,000 guideline and that approval should be subject to planning approval.
