- Highways Maintenance, Grounds Maintenance, Land drainage
- Streetpride (including parks / city centre bins)
- Parks & Open Spaces
- Leisure & Business Development (including Derby Live, libraries and events)
- Active Living and Wellbeing
- Tourism
- Culture & Arts Development
- Markets & Market Place
