Lance Dean asked that in future, schools be given a list of parents
preferences and whether they were first, second or third preference. Cathy
advised that this was not possible and was the same thing that St Benedict's
and Noel Baker were asking for. The Forum agreed that rank order details
should not be sent to schools.

Lance also asked that schools be advised of the number of statemented children to ensure that the admissions criteria can be applied correctly to all other children.

22/04 Statistics on the Secondary Transfer Process

Cathy Ford, Head of Service – Admissions, advised that 82.2% of first choice preference had been met for secondary transfers. That was a good increase for the amount of new applications that were received. There was a 46% reduction in those children who appealed for school places at community schools. These figures may have been better because of the process being more transparent. These results were very welcome, and remarkable considering how many school places there were in the city. The end result was that the outcome for parents was extremely good.

Lance Dean advised that from a foundation school's point of view the admissions process had worked quite well. However, there had been a few difficulties. Firstly they had not received the list of statemented children. Cathy Ford advised that this had been sent out a week prior to the closing date and a second copy was sent out when requested. Lance also advised that they didn't receive a copy of the waiting list and ha to request it. It was important to get the list of offers made so the school could send out admissions forms. Cathy advised that the original offer letter gave a date of 18 March to reply if they did not want the place. Lance asked how long the school should wait before giving a place to someone else. Cathy advised two full weeks, although the letter did state to advise if they did not want the place.

The Committee agreed to pay tribute to the work of the Local Education Authority staff in gaining these results, and the way they had been dealt with, ensuring that children had access to their normal area school.

23/04 Determination of Admission Arrangements for Community and Voluntary Controlled Schools 2006-2007

Cathy Ford, Head of Service – Admissions, presented a draft copy of the Council Cabinet report on the Determination of Admission Arrangements for Community and Voluntary Controlled Schools 2006 – 2007 which would go to Council Cabinet on 26 April 2005. The report recommended to agree the proposed admission arrangements for 2006 – 2007, with changes from 2005 – 2006.

Agreed to recommend Council Cabinet approve the Admission Arrangements for Community and Voluntary Controlled Schools 2006-2007.
