Adults, Health and Housing Commission Work Programme 2011-12

RECOMMENDATION

1.1 To consider and agree items for the AHH Commission's work programme 2011-12.

SUPPORTING INFORMATION

- 2.1 At the last AHH Commission meeting Members agreed to submit suggestions for the Commission's work programme 2011-12. The following items have been suggested:
 - 1. To Review the Re-ablement Service

This could look at the level and type of support offered to individuals that have experienced some form of trauma and need assistance to develop skills and confidence to look after themselves again. The review will consider:

- Number of referrals per month
- Types of conditions people enter the service
- Average age of individuals entering the service
- Number and percentage of people re-abled after intervention and not requiring the service after 6 weeks
- Number of people re-entering the service after 3 months
- Savings to authority as a result of this
- The review may also link into the Royal Derby Hospitals intermediate care service
- 2. To look at services offered and work load of Derby Advice & Housing Options.
- 3. Personalisation to consider the uptake of personalisation amongst different social needs groups.
- 2.2 In selecting topics for consideration, members should be mindful that health bodies also bring items to the Commissions as part of their requirements for consultation and also keep members informed of minor developments. This is in addition to their duty to consult on substantial reconfiguration of the service. The Commissions should therefore retain some capacity to respond to these requirements as they occur.

- 2.3 The Commission may draw on the overview and scrutiny budget which is shared between the five Commissions to assist with the work programme.
- 2.4 The Commission is asked to consider agree its work programme.
