Financial and Value for Money

1.1 2013/14 accommodation budgets

Children's Services

- Leaving Care 185k
- Localities 16/17 year olds 177k (30k contribution to Adults Health and Housing Emergency Crisis Intervention Contract)
- Additional spend is made for Children in Care requiring agency or specialist accommodation placements and costed against the overall residential accommodation budget.

Commissioning Services are currently reviewing accommodation requirements of young people and aim to draw together all the spend and produce an accommodation framework in July 2014 to ensure value for money.
