# Derby City Council and Partners Child Exploitation (CRE) Annual Report 2021-22

# Purpose

- 1.1 To provide an annual report of the partnership work on child exploitation in Derby City, documenting the activities and achievements of the local authority and its partners.
- 1.2 The Derby City Council and partners Child Exploitation (CE) Annual Report builds on work that has been developed across the multi-agency partnership of previous years. It provides strong evidence that children within the City who are affected by exploitation are safeguarded from harm.
- 1.3 Over this reporting period significant multi-agency efforts have continued to respond to the evolving landscape of exploitation and risk. These risks include child sexual exploitation, child criminal exploitation, organised crime and gangs, modern slavery and human trafficking.
- 1.4 The work has been driven through the Exploitation and Vulnerable Young People's Sub-Group of the Derby and Derbyshire Safeguarding Children Partnership, working thematically to progress the agreed priorities for this area of work.

# Recommendation(s)

2.1 The panel is recommended to accept this report as a positive reflection of the partnership approach to identifying and reducing child exploitation in Derby and to support this as a priority area of work to keep children safe from harm.

# Reason(s)

- 3.1 A range of agencies (under Section 11 of the Children Act 1989) have a duty to create cultures of safety, equality, and protection with the services they provide
- 3.2 Working Together to Safeguard Children (2018) recommends partnership work to ensure children are safeguarded and their welfare promoted (a), Partner organisations and agencies collaborate (b) and there is early identification and analysis of new safeguarding issues and emerging threats (c).
