CSPL Local Government Ethical Standards 15 Best Practice Recommendations

Purpose

- 1.1 The Standards Committee considered the Committee on Standards in Public Life (CSPL) Local Government Ethical Standards report at its meetings on 22 October 2019 and 7 July 2020.
- 1.2 Members considered the list of recommendations and the list of best practice recommendations, contained within the CSPL report.
- 1.3 In that report, the CSPL undertook to follow up the best practice recommendations with local authorities in 2020.
- 1.4 In September 2020 the Chair of the CSPL wrote to the Council's Chief Executive, seeking an update on the Council's progress against the best practice recommendations.
