Proposal:Extension to Public House (condensers), installation of kitchen<br/>ventilation system in roof space of brick barn including creation of an<br/>extract louvre in gable end and a false dormer on inner roof slope

The Committee raised no objections and welcomed the ingenuity of the solution.

#### **City Centre Conservation Area**

Application No.DER/09/11/01059 - The Old Post Office, Victoria Street, Derby, DE1<br/>1DDProposal:Internal alterations including infilling floor void and removal of<br/>staircase, display of 3 internally illuminated fascia signs, 1 externally<br/>illuminated projecting sign and 3 internally illuminated canopies

The committee did not object to the proposed internal alterations such as the removal of the staircase and filling the internal floor void. However they continued to object to the proposed external alterations but highlighted that they did believe that one externally illuminated hanging sign would be acceptable.

The Committee recommended refusal on the grounds that the 2 internally illuminated hanging signs would have a severe detrimental effect on the architectural merit of this city centre building and the uncluttered cantilevers. The Committee did not object to the 2 internally illuminated fascia signs.

Proposal: Erection of detached garage

### **Strutt's Park Conservation Area**

Proposal:	Formation of room in roof space (bedroom and en-suite) and installation of rear dormer

The Committee recommended refusal on the grounds that the installation of a rear dormer would have an adverse effect on the Conservation Area. It would also detract from the historic impact of a former ventilation shaft of a nearby factory.
