Private Sector Housing - Standards and Issues Related to Rented Properties - Update Report

SUMMARY

1.1 The report provides Members with an update since the last report.

RECOMMENDATION

2.1 That Members note the information contained in the report.

REASONS FOR RECOMMENDATION

- 3.1 To ensure that Planning, Housing and Leisure Board is kept informed of the work being done to try and address poor standards and issues related to rented properties.
- 3.2 Information relating to the preliminary research and potential options available are being considered by the Cabinet Member.

SUPPORTING INFORMATION

- 4.1 At the meeting in July 2012, the Board received information on the size and condition of the private rented sector (PRS) in Derby, the nature of the housing health and safety rating system (the legislative tool used by officers to address hazards in dwellings), the licensing of houses in multiple occupation and the proposed activities of the Housing Standards Team to address standards and issues related to the PRS.
- 4.2 One of those proposed activities set out was to undertake preliminary research to look at the options available to address poor housing standards, including the possibility of discretionary licensing power, in certain parts of the City.
- 4.3 The preliminary research work has now been conducted by the housing standards team along with partners from the Police, Community Neighbourhood Partnership, Environmental Protection Team and Derbyshire Fire and Rescue Service.
- 4.4 A report is currently being prepared for the Cabinet Member that identifies the findings from the research and options for future action. The report will be considered by the

Cabinet Member and colleagues in due course.
