Report of the Strategic Director of People Services

East Midlands Regional Children's Framework – Provider Framework for Independent Fostering Agencies and Residential Care Providers for Children and Young People

#### **SUMMARY**

- 1.1 This paper provides an update on the procurement of the new East Midlands Regional Children's Framework (EMRCF), the provider framework for independent fostering and children's homes placements and the Council's Placement Sufficiency strategy.
- 1.2 A paper was presented to cabinet in August 2015 where approval was given for continued participation in the EMRCF.
- 1.3 The tendering process has concluded, framework of providers established and the framework commenced on 1<sup>st</sup> February 2016.
- 1.4 The lots and categories are detailed in the supporting information to give an overview of the number of providers in each lot and the average core cost for each category.
- 1.5 The Local Authority's Sufficiency strategy (Appendix 2) unpins the aim of ensuring the availability of local, high quality placements.

#### RECOMMENDATION

- 2.1 To note the contents of this report.
- 2.2 To note that EMRCF will commence 1st February 2016 and expire 31st January 2020.
- 2.3 To approve the Placement Sufficiency strategy.

#### REASONS FOR RECOMMENDATION

3.1 Use of the framework is a key element of meeting the Local Authority's obligations in relation to ensuring sufficiency of provision for Looked After Children.

#### **SUPPORTING INFORMATION**

4.1 The new East Midlands Regional Children's Framework commenced on 1<sup>st</sup> February 2016 and replaced the previous regional framework which was in place for four years.

The framework consists of the following categories:

#### **Lot 1 Children's Homes**

Category 1.1 – Standard Children's Home Emotional Behaviour Difficulties provision Category 1.2 - Specialist Children's Homes Emotional Behaviour Difficulties Category 1.3 – Specialist Children's Home – Autistic Spectrum Condition with challenging behaviour – non Learning disabilities or low level Learning Disabilities. Category 1.4 – Specialist Children's Homes Autistic Spectrum Condition with Challenging behaviour – moderate or severe Learning Disabilities Category 1.5 – Specialist Children's Homes Complex Health Needs

#### **Lot 2 Fostering Services**

Category 2.1 – Standard Fostering Provision

Category 2.2 - Specialist Fostering Provision

Category 2.3 – Specialist Fostering Disabilities

Category 2.4 – Specialist Fostering Complex Health Needs

- There also specific requirements regarding Remand placements, Parent and Baby placements, Sibling placement and Solo placement. Not all providers have given a cost for these areas. Children's homes have also been asked to specify if they provide Education and waking nights, and separate costs are identified for these categories. Over half of the providers have discounts for siblings, permanence and volume.

  Northamptonshire County Council remain the lead Authority for contracting of the EMRCF, with LGSS (a shared service jointly owned by Northamptonshire County Council) responsible for procuring the Framework on behalf of all partner local authorities in full compliance of the Public Contract Register. The LGSS have produced summary report of the procurement activity and outcomes which have been shared with all partaking Local Authorities; this is available with this report.

Providers' prices have been scrutinised during the evaluation process and challenged if they are above the average benchmarked price comparing prices from the old framework.

4.4 Below are tables with the average price for each category per age group. Note that this does not include the cost of additional services which will be additional. Costs are reviewed regularly and reduced in line with the individual needs of the child/young person.

- 4.5 7 Local Authorities are part of the regional framework, these being Derby City, Derbyshire County Council, Leicester City Council, Leicestershire County Council, Nottingham City Council, Nottinghamshire County Council, Northamptonshire County Council and Rutland.
- 4.6 The new EMRCF will allow Derby City to procure a Block Contract for specialist fostering. This will be procured in the first few months of the new framework with a specified service specification.

- 4.7 Each individual placement will be sourced by a 'call off' or a 'mini –competition', this will source providers who can best meet the child/young person's needs, area of placement (with emphasis of local provisions being accessed in the first instance) and not exceeding the price that has been quoted in the tender.
- 4.8 There are a number of new providers which has opened up the market place and given Derby City more choice especially for children and young people with higher needs. The framework will be opened on an annual basis which will allow new providers to join (they will go through the same procurement process and evaluation as this exercise), which will continue to promote price competition and innovation.
- 4.9 Derby City Council have developed a Placement Sufficiency Strategy to support market development in the area of placements for children and young people who are Looked After by the Local Authority. The Strategy highlights some of the key areas for development and proposals for resolving some of the sufficiency issues currently experienced in Derby City.

Our ambition is to continue to stimulate the market place and build effective relationships with providers to enable sufficient, good quality local provision for our children and young people.

#### **IMPLICATIONS**

#### **Financial and Value for Money**

1.1 The impact of the new East Midlands Children's Framework will allow individual packages to be purchased with negotiations on reducing the costs during the period of the placement. The new Framework has impacted on the competiveness of the provider market. The new Framework also allows the opportunity to block contract where potential savings have been identified. It allows us to work with the provider market to achieve our actions on the Sufficiency strategy.

#### Legal

2.1 LGSS have led the procurement activity and the contract management for the Framework will be undertaken by the Central Regional team in Northamptonshire. Local contract management will be undertaken for each individual placement agreement (IPA) to ensure that outcomes have been completed and the provider has delivered the support procured as part of the call off.

The Block Contracts we undertake as part of the framework will be managed by Commissioning with support from our procurement colleagues.
