A Forced Marriage Group had been set up and this group was working with the Community Safety Partnership – CSP. Adrian Gascoyne explained that the CSP had taken ownership of this group and incorporated it into the Domestic Violence Working Group. An action plan had been produced by Karma Nirvana and the working group had taken this up.

**Agreed to receive an update at a future meeting with timescales incorporated in the action plan.**

## 11/07 Working with Male Perpetrators of Domestic Violence

The Forum received an update from Adrian Gascoyne on working with male perpetrators of domestic violence. This was a three year project that started in 2005 and was due to end in March 2008. There had been some successes

through the scheme. The Community Safety Partnership were now reviewing all domestic violence activity and the perpetrators programme would be part of this review.
