## **Derby Poverty Commission**

### Purpose of Report

The purpose of this report is to provide an overview of the Derby Poverty Commission, to include an update on the progress made since the launch in April 2021 and proposed next steps.

#### Recommendation

To note the report and provide feedback.

#### Context

Prior to the COVID-19 pandemic it was estimated that nationally up to 14.5 million people were in poverty when taking housing costs into account – reflecting one in every four or five people. However, the impact of the COVID-19 is estimated to have plunged a further 700,000 people nationally into poverty – over 15 million people, with countless more experiencing additional financial uncertainty and hardship because of the pandemic.

Derby was no exception to the national picture, and very quickly the pandemic exacerbated and highlighted more than before the levels of deprivation across the city, and within certain neighbourhoods and populations.

In Derby, pre-pandemic activities aimed at addressing and alleviating the effects of poverty were largely driven by community organisations, faith organisations, and other charitable ventures providing a range of services including foodbanks, clothes recycling, and debt support to name a few, however these were typically without collaboration or a joined-up approach.

However, there was a very real need for a new collective approach to tackling poverty and responding to the unfolding emergency locally. In Derby, the strength of the partnership between the city and the VCSE sector enabled the launch of an emergency food response scheme, which has continued to evolve to become the city's Food 4 Thought project.

Equally, other 'alliances' that had emerged both pre- and during the pandemic were yielding positive outcomes for young people through the Youth Alliance, strengthening the role of the Faith Sector through the Faith Forum work, plus countless other new platforms which brought together key players to work together on key themes, such as the more recent Derby Health Inequalities Partnership.

This new way of working - the 'Derby Way' - was underpinned with new governance frameworks including the city's new Partnership Board which continues to enable and embrace coproduction in tackling and resolving some of our cities deepest rooted challenges.

It was this new partnership landscape that enabled the coproduction of the Derby Poverty Commission, aimed at improving collaboration and encouraging a joined-up approach to addressing and alleviating the effects of poverty in the city. This would be achieved through an immediate (short), medium and long-term strategy, reflecting the emergency 'response', medium term 'recovery' and longer term 'resilience' of our city in respect of tackling poverty.

#### Additional Information

The Derby Poverty Commission is chaired by Peter Robinson, Dean of Derby, and is an independent Commission with membership and participation from across all sectors in the city.

The Commission focuses on the effects of poverty, identifying the root cause, as opposed to advocating short term solutions. The Commission advocates developing locally based solutions utilising the strengths of our own communities and organisations. As referred to, Derby is rightly proud of the 'Alliance models' and

frameworks in place, which were mostly born out of the COVID-19 response. The Commission works closely with these, seeking to find strength in partnership. The Commission currently operates 4 sub-groups which area each dedicated to looking at a subject area each: person, home, digital, post-pandemic.

#### Poverty Truth Commission

Poverty Truth Commissions are built on a principle of collective and participatory decision making to tackle poverty, in which people with lived experience of poverty (Community Commissioners) build relationships with those in positions of influence and power (Civic Commissioners). Working together, they co-create meaningful and longer-term solutions and change through time spent listening to one another's truth and experience.

This approach works harmoniously with the Commissions desire to work at a grass-roots level due to its involvement and leading from the residents of Derby as commissioners. A Poverty Truth project group is now in place, and we now have a dedicated full-time resource committed to facilitating the start-up of a Poverty Truth Commission and "finding" suitable lived-experience commissioners.
