# Patient-led NHS – latest update

The Secretary of State has now agreed the proposals for the Strategic Health Authority and PCT reconfigurations within the Trent region. A consultation will be led by the Trent Strategic Health Authority and will consult on the following options for Derbyshire:

- 1 PCT for Derbyshire including Glossop
- 1 PCT for Derbyshire excluding Glossop which would be linked to Greater Manchester
- 2 PCTs, 1 for the city, 1 for the county
   including Glossop
- 2 PCTs, 1 for the city, 1 for the county
  excluding Glossop

No options are identified as a preferred way forward at this stage.

## **Patient-led NHS continued**

The consultation – which starts on 14 December for 14 weeks - is only covering reconfiguration of organisational boundaries – discussions and decisions about provider functions are not included within this consultation.

In addition, there will be a separate consultation on the establishment of a single SHA for the East Midlands, coterminous with government regional office boundaries.

The responses received during the consultation process will be recorded, general themes will be collated and a report taken to the Trent Strategic Health Authority Board. They will make final recommendations to go forward to the Secretary of State.

Changes to the provider functions will be considered by the new Commissioning PCTs in light of the soon to be published 'Out of Hospital' White Paper.



## **Coleman Health Centre**

Following a consultation event in June on the Alvaston and Boulton LIFT project, several names were suggested for the new centre. The most popular name was the Coleman Health Centre. This will, therefore be the name for the new centre. Both the Meadowfields practice branch surgery in Upper Moore Road and Boulton Clinic in Wyndham Street will be moving to the new centre.

The building company appointed for all current Southern Derbyshire LIFT schemes is Laing O'Rourke. They are due to start setting up on site during December and will start on construction in January. The new centre is scheduled for completion early in 2007.

The schedule was slightly delayed due to the discovery of ground and water contamination on site through leaking oil tanks, but this has now been cleaned to Environment Agency satisfaction.
