## 07/07      Updates

### **Redevelopment of University of Derby Mickleover Campus**

A resident thanked Richard Smail for the information he had sent regarding S106 planning agreements associated with the University site. He asked if the panel could receive information about similar planning agreements at future meetings.

Councillor Jones said that if the panel wished to receive such information that it could.

### **Petition – Lighting around Vicarage Road Park**

It was reported that officers were investigating sources of funding and would bring a report to the September meeting.

Councillor Jones commented that there had been an underspend in the Area Panel budget for 2006/07 and asked if some of this money could be used for lighting a route across the park.

**Agreed to ask the officers to investigate this possibility and bring a funding application to the next meeting.**

### **Petition – Car Parking on Uttoxeter Road**

Sergeant Kilgour reported that police had been carrying out spot checks for vehicles parked in dangerous locations on the junction on Jackson Avenue and Kings Drive including blue badge holders, but that none had been found. She asked those present to contact the police directly with specific dates and times when dangerous parking is witnessed and said that her officers would continue to patrol the area.

Councillor Care reported on the Kings Drive Residents' Parking Scheme consultation and said that one objection had been received with respect to imposing a waiting restriction and once that had been investigated by the appropriate officer that a report would be drafted.

## 08/07 Public Question Time

### **Gayton School Pool**

A number of questions were asked by members of the public in relation to the proposed closure of Gayton School Pool. The issues included:

- Whether consideration had been given to using a private company to run the pool
- What risk assessments had been carried out in relation to the pool's decommissioning
- Draining the pool
- What profit or loss the pool had made

A number of people asked what else could be done.

Councillor Jones urged those present to submit questions to the next Council on 18 July 2007 and advised that questions needed to be submitted by 12 noon on 10 July. She said that her group would put forward a motion would put forward a motion at the next Council meeting on behalf of her group.

### **State of road junction at Corden Avenue and Uttoxeter Road**

A member of the public raised concerns about the standard of the road condition at the junction of Corden Avenue and Uttoxeter Road. Councillor Care reported that it has been an issue for some time and that work around the junction is dependent on funding from a section 106 agreement and traffic light improvements. She agreed to investigate and report back to the resident.

Councillor Troup said that a new maintenance contract for highway repairs was currently being negotiated.
