The minutes of the meeting held on 9 November 2006 were approved as a correct record and signed by the Chair.

101/06 Applications dealt with under Building Regulations and Associated Legislation

Resolved to note the applications for Planning Permission determined by the Assistant Director – Regeneration under delegated powers and detailed in Section E (Delegated) of the report and the applications detailed in Section B1 of the report be dealt with in accordance with the Assistant Director – Regeneration's, recommendations or as determined by the Committee as follows:

- a) Applications Recommended for Approval or that no objections be raised by the Council subject to any conditions set out in the report and
- b) Applications determined by the Committee

1. DER/1006/1562 Erection of Children's Centre together with associated fencing, play area, vehicular access and alterations to existing school building at land off Audrey Drive, Chaddesden (part of grounds of Cavendish Close Infants School, Wood Road).

Having declared a personal prejudicial interest, Councillor Bolton left the meeting during consideration of this item.

The views of the Police and Arboricultural Officer were reported.

Mr Sheppard and Councillor MacDonald in objection to the application and Mr Nizzer on behalf of the applicant addressed the Committee.

Resolved to grant permission with conditions as set out in the report.

2. DER/906/1544 Pruning of 12 Lime trees, protected by TPO No. 288 (2001) at St Georges House, St Georges Close, Allestree

In the absence of the Councillor who requested that the matter be brought before the Committee it was agreed to delegate authority to Officers to determine the application.

Resolved to refuse planning permission on the following grounds : 'In the opinion of the Local Planning Authority the hours of operation of the proposal, compounded by the restricted parking and turning facilities given the location of the dwelling to the rear of frontage properties, results in an unacceptable loss of amenity for nearby residents by virtue of the additional vehicle and pedestrian activity and general disturbance, particularly during the evening when occupiers of nearby residential properties would reasonably expect to benefit from the peaceful enjoyment of their homes. The proposal is accordingly contrary to adopted City of Derby Local Plan Review 2006 policies GD5, L11 and EP13.'

Agreed that Councillor Carr would represent the Committee at any appeal.

5. DER/806/1360 Demolition of bungalow and erection of 2 storey dwelling including basement at 'Trelawney' 16 Parkfields Drive

Having declared a personal prejudicial interest, Councillor Carr left the meeting for consideration of this item.
