HMIP Inspection of Derby Youth Offending Service

SUMMARY

- 1.1 Derby Youth Offending Service (YOS) was subject to an inspection under a new framework delivered by HMIP in June 2018. This included a 2 week preparatory period and a week of fieldwork, where the inspection team visited Derby to gather evidence against which to assess the performance and quality of the service delivered to young people and families.
- 1.2 This was the first such inspection under the HMIPs new inspection regime and gave Derby an opportunity to showcase its work. A power point presentation outlining the key findings has been prepared for scrutiny committee.

RECOMMENDATION

- 2.1 To note the key findings from the HMIP inspection of Derby YOS.

- 3.1 To ensure Scrutiny Committee are kept abreast of the progress being made by the YOS against the quality standards applied by an external scrutiny body and plans to remedy areas for development that have been identified by HMIP.
