## The Apprenticeship Project update

## Purpose

## Supporting information

### 4.1 Apprenticeship Project current priorities

### 4.1.1 Covid19 impact on current apprenticeship programme delivery

Now that we have started on the roadmap out of lockdown several of our training providers are reviewing their training delivery models. We have had a mixed response from the providers on what the new normal will look like. Some are not intending to go back to face to face delivery and will continue with virtual classes and only deliver face to face assessments and exams. Others are going back to face to face or a blended approach with the appropriate risk assessments in place and following the current social distancing guidelines.

Some managers have raised concerns regarding virtual classes and teaching contact time in the long term particularly with the younger apprentices who may need more support. Council officers are continuing to hold regular account management meetings with key providers and will continue to monitor this along with the quality of the provision.

### 4.1.2 Management and Leadership Programme

The Council's management and leadership programme is continuing to be very successful we had several new starts in January 2021 and the signs are very encouraging for some high grades for the next cohort of completers.

Another positive is that colleagues who had to take a break in learning mainly due to the Covid19 pandemic impacting on their workload are now feeling able to return to complete their programme.

We are now receiving expressions of interest for the next intake in September 2021 and are continuing to work in partnership with the University of Derby to provide these programmes.

### 4.1.3 Procurement Contracts and Data Processing Agreements

Currently Council officers are working with Procurement, Legal Services, and Information Governance to put new procurement contracts and Data Sharing Agreements in place with several external training providers.

This is proving a lengthy process due to the complexities of the multifaceted negotiations between our internal services and external legal representatives.

### 4.2 Budget announcements and Government Incentives

### 4.2.1 Budget 2021

The government announced several new measures related to apprenticeships in the Budget earlier this month. These included:

- Apprenticeship Incentive Payments
- Increased to £3k per new apprentice - regardless of age
- Extended through to end of September 2021
- Will continue to be paid in addition to any other incentives the apprentice may be eligible for (e.g. 16-18)
- New Flexi-Job Apprenticeship
- Apprentices can be linked to an agency instead of one employer and take on jobs with multiple businesses
- Targeted at industries with more flexible working patterns (e.g. TV \& Film / Construction)
- Employers can bid for a share of a $£ 7 \mathrm{~m}$ fund to create new agencies first 'flexi-job' expected in Jan '22
- Expansion of Traineeships
- Extra $£ 126 \mathrm{~m}$ to expand traineeships by an extra 40,000 in 2021/22
- Includes $£ 22 \mathrm{~m}$ to continue the employer incentive payments of $£ 1,000$ per trainee
- December’s Spending Review previously confirmed $£ 2.5$ bn for apprenticeships and further improvements and announced plans for a new online Levy Transfer matchmaking service from August 2021.


### 4.2.2 Kickstart Scheme

Employers can use the Kickstart Scheme to:

- Create 6-month job placements for young people currently on Universal Credit and at risk of long-term unemployment.
- Support participants to develop skills and experience needed to find work after completing the scheme.
The DWP will initially prioritise young people aged between 16 and 24 supported by their Jobcentre Plus work coach to enrol on the scheme. Funding is available for $100 \%$ of the relevant National Minimum Wage for 25 hours a week, plus associated employer National Insurance contributions and employer minimum automatic enrolment contributions. $£ 1,500$ per job placement available for setup costs, support, and training.
4.2.3 Derby Employment Hub are promoting these incentives to local employers and our external partners.
Council officers are encouraging our managers to take advantage of these incentives, exploring job placements, and recruiting to new start apprentices where appropriate with the required support considering the new ways of working.


### 4.3 Levy Payments

4.3.1 As of 25 March 2021, the Council has transferred a total of $£ 2,862,543.56$ into the Education and Skills Funding Agency (ESFA) Apprenticeship Levy Digital Account and has drawn down $£ 1,084,519.24$ for apprenticeship training programmes.

The Council is now experiencing the expiration of funds monthly: as of 25 March 2021, this amounts to $£ 391,667.15$ in total.

The total Levy drawn down including expired funds is $£ 1,501,357.89$.
This equates to $52 \%$ of our Levy fund.
Please refer to appendix 1 for a breakdown of payments.

### 4.4 Employment and Skills Board

4.4.1 The Apprenticeship Board was disbanded in November 2020, the proposal was to promote a more joined up approach across service areas and to create more inclusive Employment and Skills Board.

The proposed Board members were Cllr Williams - Chair, Service Director for Learning, Inclusion and Skills, Head of Adult Learning Service, Head of Economic Growth and Head of Organisational Development and the Apprenticeship Project Manager.
4.4.2 The actions from the Personnel Committee held on the 16 November are to be carried forward as actions for the new Employment and Skills Board when it has been convened.

Actions to carry forward:

- To refer to the Employment and Skills Board to investigate whether apprentices at the Council should be payed the 'living wage' as defined by the Living Wage Foundation.
- To refer to the Employment and Skills Board to investigate how local schools could be assisted in helping young people to secure apprenticeships.
- To refer to the Employment and Skills Board to investigate how the Council could help to increase the number of first-start apprenticeships in Derby.
4.4.3 At this time the creation of the Employment and Skills Board is dependent on conversations within our Learning Inclusion and Skills Service.


## Public/stakeholder engagement

5.1 Council departments, external training providers and local businesses.

## Other options

6.1 Do nothing. This is not considered to be a viable option, the main reason being the Council wants to maximise the Levy spend.

## Financial and value for money issues

7.1 The Council continues to make contributions to the Levy on a monthly basis. Some of the funding is being used to pay for apprentice programmes every month. The Council has a rolling 24 months to use the funds and is now experiencing the expiration of funds on a monthly basis.

## Legal implications

8.1 We are continually working with Legal and Procurement Services to ensure we are meeting our legal obligations with the Levy and procurement rules. The Government have put legislation in place; 'The Public Sector Apprenticeship Targets Regulations 2017'. Public sector bodies in scope of the target must submit annual returns appropriately demonstrating that they have had regard to achieving the $2.3 \%$ target. The Government have not put any penalties in place for not meeting the target the onus is on having regard for it.
