## **Topic Review 2018-19 – Child Poverty in Derby**

### **Purpose**

- 1.1 The Children and Young People Scrutiny Review Board agreed that Child Poverty in Derby form the basis of its topic review for the 2018/19 municipal year at its meeting on 9 July 2018.
- 1.2 The Chair and Vice-Chair of the Board have invited representatives from partner organisations to give evidence on how they are prioritising and supporting a reduction in child poverty in the city.
- 1.3 As the last meeting of the municipal year, the Chair has requested that consideration is also given to final recommendations arising from the Topic Review and that the process for drafting a final report is discussed.

### **Recommendations**

- 2.1 To consider draft recommendations arising from the Topic Review and to discuss the process for preparing a final report.

### **Reasons**

- 3.1 To ensure the Board gains a thorough and complete understanding of child poverty in Derby as part of its topic review, it is important for evidence to be gathered from a wide range of sources and stakeholders. This can include evidence from council officers, external partners and service users.

- 4.1 The Board has been collating evidence throughout the year for the Topic Review. This being the final meeting of this year for the Board it is an opportunity to review the evidence received to date from the Topic Review and propose draft recommendations for the final report.
