Local Land Charges Fees and Charges

SUMMARY

- 1.1 Local Land Charges Service fees are reviewed periodically to ensure that the service continues to cover costs. Environmental Information Regulations (EIR) provide for a free service for a Personal Search of the Local land Charges Register and CON29 element, but those fees which are discretionary need to be adjusted.
- 1.2 We have reviewed all of the fees and charges for the service and this report seeks approval for the implementation of the new pricing levels from 1 April 2015.

RECOMMENDATION

2.1 To approve the fees and charges for Local Land Charges, as set out in Appendix 2, to be implemented from 1 April 2015.

REASONS FOR RECOMMENDATION

3.1 To ensure that the Local Land Charges Service continues to cover costs and contributes to the budget challenge facing the council.

SUPPORTING INFORMATION

- 4.1 It is proposed that the form LLC1 fee, for a residential property is increased from £29 to £32.50. For a Commercial property the LLC1 fee will increase from £49 to £74. The fee for each additional residential parcel of land increases from £20 to £25 and Commercial from £20 to £50 due to the additional complexity of commercial sites.
- 4.2 It is proposed that the CON29 Part 1 (2007) Enquiries fees for one parcel of residential land remains at £50, however, for each additional parcel the fee rises from £20 to £25. CON29 Fees for the first parcel of commercial land rise from £150 to £175 with each additional parcel rising from £20 to £50 due to the additional complexity of commercial sites.

- 4.3 It is proposed that the fee for the CON29 Part 2 enquiry for Register of Common Land Searches increases from £6 to £15 for residential enquires and from £6 to £20 for Commercial enquiries.
- 4.4 It is proposed that the fee for the CON29 Part 2 enquiry for each printed enquiry increases from £12 to £15 for residential enquires and from £12 to £20 for Commercial enquiries.
- 4.5 It is proposed that the fee for each additional enquiry (including solicitors own enquiries) increases from £25 to £30 for residential enquires and from £25 to £40 for Commercial enquiries.
- 4.6 It is proposed that a fee be introduced for the provision of a map showing a plan of the adopted highway boundary and this will be charged at £40.
- 4.7 It is proposed that a fee be introduced for the provision an expedited residential search service, where this can be accommodated, be introduced at £41.25 per search.
- 4.8 It is proposed that the Official Local Authority compiled (standard) search comprising of forms LLC1 and the CON29 Part 1 (2007) increase from £79 to £82.50 and that an Official Local Authority compiled commercial search increases from £199 to £249 per search.

OTHER OPTIONS CONSIDERED

5.1 To not amend the fees. This is not considered a viable option as the proposed fees and charges better reflect the costs to the service in providing responses to both residential and commercial search requests than those currently in place.
