

CAMHS Action Plan – in response to CYP Commission Topic Review

Recommendation 1 – to Derby City Council Mental Health Services and Derbyshire Healthcare NHS Foundation Trust

The Commission acknowledges the weaknesses of the Strength and Difficulties Questionnaire as a tool to measure children in care's mental health. The Commission recommends that all relevant partners should work together to determine whether complementary processes can be put in place locally to ensure that CLA receive a thorough assessment in order that those with mental health and/or emotional difficulty have their needs met appropriately and at an early stage.

- a) The Commission asks that all Head Teachers are given a presentation at their Head Teacher's Briefing in September 2011 about recognising children with emotional difficulties/mental health needs and are given information about how to support children in the first instance and to determine whether a referral to specialist services is appropriate. This will assist in ensuring that children receive early intervention with any problems and will help to prevent their problems from escalating. Specific information should be supplied about the need to support CLA in this regard. A presentation on this issue should be given annually at their September meeting.
- b) Similarly a presentation on this issue should be given to all Chairs of Governors on an annual basis.
