Members received a presentation from Tamara Dale, Ridgeway Infant School, on experiences of teaching RE at the school.

### 45/16 Presentation about Teacher Visit to India

Members received a presentation from Alison Brown about a recent teacher visit to India. It was reported that a group of 19 people had taken part in the visit, including 15 teachers. It was further reported that this was an ongoing partnership with schools in Calcutta, with the aim of forging links between schools. It was noted that a resource box had been used in the schools visited. It was also noted that another visit was planned for January 2018 and that there were also future plans for some teachers from India to visit England.

Members asked whether the resource box was something that could be disseminated to schools. Alison agreed to put this to the group at their next meeting.
