Understanding Communities National and Local Data Sources

Key Findings

Derby's population is very diverse. It has changed significantly since 2001, and continues to change. Notably within Derby's population:

- Between 2001 and 2011, the percentage of Derby's population from BME groups increased from 15.7% to 24.7%
 - The "White Other" (which includes Eastern European nationalities) and Pakistani communities increased most during this period.
- In 2012/3, it is estimated that 36% of Derby's 0-16 population are from BME communities.
- In 2013, Public Health databases identify at least 40,775 people living in Derby who were born outside the United Kingdom (or 15.3% of the population). Within this, at least...
 - 11,540 people were born in Pakistan, India and Bangladesh
 - 11,170 people were born in the A8 accession countries.
- There are people living in Derby who were born in at least 180 different countries.

1. Introduction - Population change

1.1 City level population change

Between mid-2005 and mid-2011, the Office for National Statistics, ONS, estimate that Derby's population increased by 11,600 people; from 237,300 to 246,900 (ONS Mid-year Estimates of population, MYEs, 2005-2010).

Locally, Public Health databases recorded that there were 266,979 people living in Derby in March 2013. (It should be noted that there have been consistently, significantly more people registered on the GP Patient Register in Derby than the population estimated by the ONS.)

2.Ethnicity

2.1 Ethnicity

In 2011, 24.7% of Derby's population were from BME communities. This is greater than in either the East Midlands (14.6%) or England (20.2%) - see Table 2.1.1.

The Asian/Asian British community was the largest ethnic group within Derby, comprising 12.6% of the total population. Within this group:

- the Pakistani community represented the largest BME group in Derby, comprising 5.9% of the total population, and
- the Indian community was the second largest BME group, making-up 4.4% of the total population.

Notably, the "Other White" ethnic group, which includes migrants from Eastern Europe, accounted for 3.9% of Derby's population in 2011 making it the third largest BME group in the city.

As illustrated in Table 2.1.2, Derby's BME communities are concentrated in central areas of the city – this is further illustrated in Figure 2.1.1. In Arboretum and Normanton, approximately two thirds of the population are from BME communities. Further, in Abbey, Sinfin, Littleover and Blagreaves approximately one third of the population are from BME communities.

Notably, the largest numbers of people from the "Other White" ethnic group are located in:

- Arboretum (10.1%),
- Normanton (7.7%), and
- Abbey (7.5%).




Figure 2.1.2 – Location of BME Groups in Derby, 2011

Ethnicity information, for the whole population, is incomplete within local data sources. However, there is comparatively complete ethnicity information available for the 0-16 population.

The indicative ethnicity profile of the 0-16 population is significantly different from the census estimates shown in Table 2.1.1. As identified in Table 2.1.3, 36% of the population aged 0-16 are from BME communities (whereas 24.7% of the total population are from a BME background). Notably, within the 0-16 population:

- 10.3% of the 0-16 population are from the Pakistani community compared to 5.9% of the whole population
- Children and young people from a dual heritage background comprise 6.2% of the 0-16 population compared to 2.9% of the total population
- 0.8% of the 0-16 population are from the Gypsy/Roma community

N.B. – this data has been compiled by aggregating data from different sources and dates. It should therefore be treated as indicative only.

2.2 Changes in ethnicity, 2001 to 2011

Between 2001 and 2011, the percentage of Derby's population from BME groups increased significantly from 15.7% to 24.7%.

The majority of BME groups increased in size between 2001 and 2011 however, the most significant increases were:

- White other, which includes Eastern European nationalities, from 1.7% to 3.9% (2.2%),
- Pakistani, from 4.0% to 5.9% (1.9%), and
- African, from 0.2% to 1.3% (1.1%).

3.Country of birth

In 2011, therewere 7.5 million peopleliving in England and Wales who were born abroad; this was equivalent to 13% of the total population (Census, 2011).

Approximately 34,600Derby residents (or 13.9% of the city's population), in 2011, were born outside of the United Kingdom – see Table 3.1.1. Of Derby residents who were born outside of the UK, approximately:

- 9,400 people were born in EU member states, of which more than 7,000 people were born in countries acceding to the EU between 2001 and 2011
- 23,400 were born outside the EU.

Locally, in March 2013, Public Health databases identify that there are at least 40,775 peopleresident in Derby, who were born outside of the United Kingdom. This is equivalent to (at least) 15.3% of the population.


There are people resident in Derby from at least 180 different countries outside the UK (Public Health databases and Electoral Register, February/March 2013). As identified in Figure 3.1, the majority were born in Pakistan, India or EU countries. A full list of countries of birth is shown in Appendix 1. Notably, there were at least:

- 11,540 people born in Pakistan, India and Bangladesh
- 11,170 people born in the A8 accession states.

Figure 3.1.3 – Main Countries of Birth of Derby Residents who were Born Outside the UK, March 2013





The figures taken from GP Patient Registers are possibly more accurate and up to than those recorded within the 2011 Census, partly due to the census only having a 92% return.

4.Year of Migrant Arrival in the UK

The number of migrant arrivals in Derby has always fluctuated. Pre 1961 the number of arrivals was comparatively small, peaking at 1,969 between 1951 and 1960. 1961-1970 saw a sudden increase with 4,133 new migrants, however, from 1970 to 1990 the number of new migrants declined, falling to 3,012 between 1971 and 1980 and to 2,332 between 1981 and 1990. 1991-2000 saw another rapid increase in migration to 4,571 followed by another drop to 3,824 in 2001-2003. 2004-2009 saw the most notable increase in the number of new migrant arrivals, the peak being between 2004 and 2006 when there were 6,064 migrant arrivals. In more recent times the numbers have fallen significantly from 5,848 in 2007-2009 to 2,112 in 2010-2011.

5 Migrant Age upon Arrival in the UK


Table 5.1 shows that certain age bands are dominant amongst migrants into the city. Of particular note are the 18,142 migrants that comprise the 20-44 age categories. Of these, the most notable is the 20-24 year olds with 7,359 migrants. The other significant migrant age band is the 0-4 year olds (4,087) which shows that a large number of very young children are accompanying their parents into the city. The latter in part clarifies the fact that the majority of adult migrants into the city are of a comparatively young age.

The majority of migrant residents have been living in Derby for more than ten years, 17,041; however, some of the recent migrant numbers are very significant. 3,634 migrant residents have been living in Derby for less than 2 years and 6,150 have been resident for two years or more, but less than five
