Report from Health & Wellbeing Boards

Purpose

- 1.1 This report provides the Integrated Care Partnership (ICP) with an overview of the recent work of the Derby and Derbyshire Health and Wellbeing Boards.

Recommendations

- 2.1 To note the work of both the Derbyshire Health and Wellbeing Board and Derby City Health and Wellbeing Board.
- 2.2 To consider if there are any implications for the ICP.

Reason

- 3.1 To ensure that the ICP is kept updated on the work of Derby and Derbyshire Health and Wellbeing Boards to:
 - support alignment and joint effort on shared outcomes
 - minimise risk of duplication of effort
 - maximise opportunities for work that is value-adding at an ICS footprint
 - identify and mitigate shared risks.

Supporting information

Derbyshire Health and Wellbeing Board

- 4.1 Derbyshire Health and Wellbeing Board (HWB) has continued to meet in its new format, which includes elected member representatives from all district and boroughs and is beginning to focus its work programme around key priorities associated with the primary and secondary prevention agenda.
- 4.2 The HWB met on 25 January and a range of development activity for the HWB has been agreed. This development activity is summarised below and will ensure that the HWB is fit for purpose within the new context of the ICS and Board development is also reflected in the strategy refresh which will take place throughout the 2023/24 financial year.
- Refreshed performance arrangements for the HWB are in place and will be developed throughout 23/24
 - Agreement to the development of the Derbyshire Place Partnership, a group aligned with the Integrated Care Partnership, to also enable work of the Derbyshire HWB as a joint engine room. Representation from district and borough councils to this group was agreed
 - Agreement of HWB role profiles
 - Agreement to undertake HWB development sessions as private meetings of the Board throughout 2023/24
 - Timetable for development of Joint Local Health and Wellbeing Strategy for Derbyshire agreed as follows:
 - January 2023 – nominations for representatives for working group
 - March 2023 – utilise the latest version of the JSNA to identify needs. Establish working group and identify key priorities
 - July 2023 – draft JLHWBS to Health and Wellbeing Board and consultation
 - October 2023 – Update on progress of draft strategy
 - January 2024 – Board to approve final strategy
 - The strategy will have due regard to the Integrated Care Strategy and will also be informed by the Derbyshire Joint Strategic Needs Assessment.
- 4.3 The HWB also noted the ongoing work to develop the Integrated Care Strategy.
- 4.4 Finally, the HWB agreed to undertake a specific development offer from the Local Government Association and this offer has been widened out to Derby Health and Wellbeing Board and the Integrated Care Partnership. Health and Wellbeing Boards now having a slightly realigned role within Integrated Care Systems, the LGA has several new products to support ongoing development of the Board via the Leading Healthier Places Support Offer. The LGA have proposed the following:
1. Undertake activities to further explore the new shared landscape for health and local government colleagues at both system and place level

2. Deliver a bespoke workshop entitled 'When Worlds Collaborate' to explore further opportunities to align the work of local government in the broadest sense, place-based service provision, health, social care and public health
3. Provide critical friend input to strengthen the role of the HWB within the ICS. The critical friend would undertake interviews with HWB members and wider partners to understand the challenges and aspirations for the HWB. The findings would be used to inform further development of the Board.
4. Review the format of the HWB and look at good practice models elsewhere to see the art of the possible and establish how the HWB could be best utilised as a driver for change.

A joint date for the proposed development session has been identified and this is 15 June 2023 and will be held at a central Derby venue.

- An Update on Warm Spaces and Household Support Fund
- Carers strategy 2020-2025 (2022 Refresh)
- Health Protection Board update
- Healthwatch Derbyshire update
- Health and Wellbeing Board Round Up Report and workplan for the Board
- Housing Stock Condition survey update.

Derby Health and Wellbeing Board

- 4.7 Derby HWB met on 19 January. The meeting had a focus on its, and the wider system's, Turning the Curve priority relating to housing and homelessness. Two items considered the Health Impacts Arising from Poor Housing Conditions and Single Homeless Adults in Derby: A Health Needs Assessment formed the substantive element of the agenda.
- 4.8 The first item provided an overview of two recent reports undertaken that relate to the very poor conditions that exist within the worst of Derby's private rented sector homes and secondly the impact that poor quality private sector housing has on the health of Derby's residents.
- 4.9 The reports highlighted significant levels of poor housing standards in the city and noted that this is disproportionately experienced by some parts of the city. The health impact assessment reported a clear correlation between ill health and poor-quality private sector housing.
- 4.10 The second item presented the findings of the health needs assessment of single homeless adults in Derby, which was conducted in 2021 and 2022. It provided an overview of the health needs of single homeless adults in Derby, the gap that exists in terms of health with the general population and the gaps and opportunities to

meet their health needs and reduce inequalities in access, experience and outcomes of health and care services.

- 4.11 The HWB debated the issues raised and how to work better together across the system particularly in relation to achieving more preventative and responsive services. It was agreed to further consider the relative role of the HWB and other parts of the health and care system including the ICP.
- 4.12 The HWB also received an overview of the guidance published by the Department of Health and Social Care (DHSC), '[Health and wellbeing boards – guidance](#)' on 22nd November.
- 4.13 The published guidance is non-statutory and sets out the roles and duties of HWBs and clarifies their purpose within the new health and care system, particularly the establishment of integrated care boards (ICBs) and ICPs. The statutory functions of HWBs remain unchanged.
- 4.14 In addition, the HWB received reports on the following for its information:
- Joined Up Care Derbyshire Update – Integrated Care Partnership and Integrated Care Strategy
 - Better Care Fund 2022/23 – amendment relating to the Adult Social Care Discharge Fund
 - COVID Outbreak Engagement Board and Health Protection Board Update.
