# The Children's Rights Service - Update

#### **SUMMARY**

- 1.1 Provision of the Children's Rights Service (CRS) is enshrined in legislation for looked after children through the Children Act 1989 and through related regulation and guidance. The Council has a statutory duty to provide advocacy services for looked after children making complaints and to appoint independent visitors.
- 1.2 As the last CRS contract came to an end on 31<sup>st</sup> March 2017, in preparation for this a review of the services was undertaken. A comprehensive tendering process was completed. SOVA (Safeguarding of Vulnerable Adults) were awarded the contract and they began providing some elements of a CRS as from April 2017. As part of the wider review it was agreed the Children in Care Council element would be brought in house with the appointment of part time participation officer.
- 1.3 As from 1st April 2017 SOVA have provided:

#### The Independent Visitor Service

Where it is thought to be in their best interest, children and young people are asked if they would like an Independent Visitor. Independent visitors are carefully matched taking into account shared interests, location, personality and any matters raised by social care practitioners. The service agreement with Derby City Council is for 40 + matches at any one time.

#### The Independent Advocacy Service

An advocate can help a child or young person make a complaint or any other representation about their care. They can accompany them to reviews or other meetings and ensure that their voice is heard. Referrals can be made by anyone and once received they are responded to within two working days, allocated based on suitability, complexity, location and availability.

#### Independent Advocacy at Child Protection Conference

Independent advocacy support for children/ young people at initial child protection conference. Includes meeting with the child/ young person to obtain their wishes and feelings and take these to the conference or supporting the child / young person to do so. Meetings only ever take place with the child/young person if that is their wish and with the express permission of their parents.

From January 2018 - Independent Advocacy for children privately fostered This is a new element and has been agreed in January to provide independent advocacy services for children and young people that are privately fostered.

1.4 This is firs year that SOVA have provided services and this update provides an overview of their challenges and achievements so far. A full annual report will be presented to the Corporate Parenting Committee Programme in the next municipal year.
