What is Adult Social Care?

Adult Social Care is about providing personal and practical support to help people live their lives. This support is designed to maintain and promote the independence and well-being of disabled and older people, and informal carers. There is a shared commitment by the Government, local councils and providers of services to make sure that people who need care and support have the choice, flexibility and control to live their lives as they wish.

What are we consulting you about?

Our 'Your Life Your Choice' Strategy sets out what we have been trying to achieve - our purpose, our principles and our approach to meeting the rising demand for social care. The original Strategy for Derby was first published in April 2015. In line with best practice, we are now in the process of refreshing this to make sure it is up to date and relevant for the coming years.

In order to ensure our ambitions meet the needs of our citizens we have been listening to the views of our social care users, Carers and other stakeholders throughout the year. We have used this valuable feedback, together with what we know about our overall performance compared to other Councils, to develop some key priorities that we want to focus on in the refreshed Strategy.
