

## The Children's Rights Service – Annual Report 2017- 18

### SUMMARY

#### Children in Care Council Summary

On the 1<sup>st</sup> of April 2017 advocacy and independent visitor services changed from Volunteering Matters to SOVA. The annual report provides information about how SOVA have continued to provide these services. As part of the change two of the staff moved over from Volunteering Matters to SOVA.

Over the year SOVA have worked hard to keep their existing volunteers who provide the advocacy and independent visitor services, unfortunately some left when the move took place, so they have been busy recruiting and training more volunteers.

Over the year SOVA advocacy have provided help and support to over 62 young people in care. They have a monthly clinic in each of the residential homes so young people can speak to the advocates. It has been agreed with SOVA that they should at least provide 40 independent visitor matches to young people in care. At the end of the year there were 38 matches. Young people who live a way from Derby and who do not have any regular contact with family or friends are given priority for independent visitor matches.

SOVA also provide advocacy to help young people get their views across at the initial child protection conferences. These are children that still live at home. This has worked well over the year and continued to grow.

- 1.1 Provision of the Children's Rights Service is enshrined in legislation for looked after children through the Children Act 1989 and through related regulation and guidance. The Council has a statutory duty to provide advocacy services for looked after children making complaints and to appoint independent visitors.

The Children's Rights Service in Derby is made up of 3 services and from the 1<sup>st</sup> April 2017 it has been delivered by SOVA<sup>1</sup> the services include;

- The Independent Visitor Service

- The Independent Advocacy Service for all children in care (Since January 2018 this has been expanded to include children who are privately fostered)
- Independent Advocacy at Child Protection Conference

1.2 Since taking over the contract for children rights service on 1<sup>st</sup> April 2017, SOVA has worked hard to develop partnerships and provide quality children’s rights service. In 2017/18 SOVA have received 62 advocacy referrals, which covered a range of themes including placement issues, support for meetings/reviews and education issues. Advocacy clinics in residential centres have continued to take place on a monthly basis.

Advocacy in child protection conferences has continued to be provided and over 2017/18 73 young people were supported to participate in over 38 separate conferences.

In January 2018 SOVA agreed to provide independent advocacy to children that are privately fostered. There are a small number of children that are privately fostered.

In 2017/18 SOVA received 28 new referrals for independent visitors, There were some teething problems at the start of the years but these have now been resolved and currently at the end of year 38 young people have an independent visitor in place.
