# Streetpride Devolved Budgets to Neighbourhood Boards

## SUMMARY

1. As pre-decision scrutiny, on 20 October the Neighbourhoods Commission considered the proposals due before Council Cabinet at this meeting.

## RECOMMENDATION

That Council Cabinet approve the proposals with the following modifications:

- 2.1 That three (not two) ward councillors be included in 'signing off' and agreeing any subsequent variation to the Neighbourhood Spending Plans, NSP, but, in the absence of a consensus, two have authority to do so.
- 2.2 At the request of ward councillors the area co-ordinator will provide information about Streetpride service standards and expenditure plans to ensure the 'additionality' of devolved expenditure decisions.
- 2.3 Subsequent to 'sign off' of the NSP the Board be informed which items will be undertaken when during the 12 month period.

## REASONS FOR RECOMMENDATION

- 3.1 Regarding recommendation 2.1, the Commission accept that using full Board meetings for agreement would impede real progress due to the meeting cycle. However it is preferable to involve all three ward members, as happens currently with Ward Committees. This would also avoid the possible public perception of there being two tiers of ward councillors. An inclusive approach is in itself likely to promote consensus as all three would be party to the same level of information. The fall back of majority decision making avoids any risk of delay.
- 3.2 Regarding recommendation 2.2, both ward councillors and the local public need to feel confident that local expenditure decisions will provide more services, or an extra amenity, on top of what would have been delivered any way. Streetpride service standards and mainstream expenditure plans can provide that information, with area co-ordinators able to give ward councillors answers and advice before NSPs are finalised.
- 3.3 Regarding recommendation 3.3, subsequent to NSP sign off and near the start of the financial year ward members and the wider Neighbourhood Board need to be informed 'what will be done when'. This can greatly assist in managing public

expectations, for example, it is far better to know in April that new signage is planned to be installed the following February, rather than the position being unclear and the public then asking in June and September why nothing has happened.

## SUPPORTING INFORMATION

4.1 On 20 October Tom Knight, Interim Director of Streetpride, and Paul Robinson, Strategic Director for Neighbourhoods, were interviewed by the Commission on the proposals now before Council Cabinet. All members were positive about the principle but at the outset had a number of concerns about the process and practicalities. These issues were fully explored in the lengthy dialogue. Members made the three recommendations set out at 2.1 to 2.3 above. Subject to those being accepted by Council Cabinet the Commission endorse the proposals. Mr Robinson indicated his willingness to modify the scheme to meet the Commission's wishes

## IMPLICATIONS

## Financial #

1.1 The proposals will not increase or decrease net expenditure on Streetpride. Instead a further £10,000 will be devolved to each Neighbourhood. The total of all Neighbourhood-controlled funds will rise from £26,000 per year to £36,000.

#### Legal +

2.1 Section 236 of the Local Government Act 2007 enables the delegation of decision making authority to ward councillors, provided that a written record is made of every decision. The proposals before Council Cabinet accord with that and offer a transparent and, when necessary, swift means of decision making. In contrast Ward Committee meeting have to be called with five clear days notice to comply with the 1985 Access to Information requirements.
