Please accept this correspondence as notification that it is the intention of the Chief Officer of Police to object to the Temporary Event Notice submitted to Derbyshire Constabulary on Tuesday 10 August 2021 in relation to the premises known as Colombo House, Shaftsbury Street, Derby. This is an unlicensed premises which has been used for licensable activities on an ad hoc basis for some years.

This objection notice relates to a Birthday party from 1600hrs on 04 September 21 through to 0400hrs 05 September 2021. The premises user on the notice is Mr Revel Orchard Pryce. It is submitted that, when having regard to the proposed hours relating to licensable activities detailed in the Temporary Event Notice (TEN), when balanced with the proposed steps to promote the licensing objectives, the proposed Notice if allowed without challenge could undermine the crime prevention, public safety and public nuisance objectives.

It is the view of the Chief Officer of Police that this notice, if granted without suitable and adequate safeguards (which cannot be enforced on a TEN) could cause unwanted alcohol fuelled anti-social behaviour and crime and disorder into the early hours of the morning. This Notice would allow a captive audience access to alcohol for an extended period of time into the early hours of the morning. The applicant who is a personal licence holder has stated that it is a party for his birthday and that he will be running the bar himself. It is of course not possible to attach any conditions to this TEN to ensure that the Four licensing objectives will be adhered to.

The premises is in an industrial area of the city away from taxi ranks and other means of easy egress from the area for people who will likely be heavily intoxicated at the time of the morning that this Notice will end.

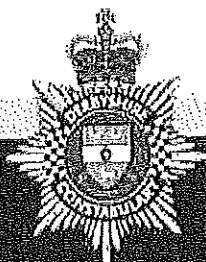


