## 8/04 Announcements from the Mayor

The Mayor read the following statement to the Council concerning the future of the Department of Works and Pensions site at the Wyvern, Derby:

"Yesterday the Department of Works and Pensions announced that as part of its modernisation plans the Pension Centre at the Wyvern Business Park is to be transferred to Job Centre + to operate as one of their new "Jobcentre Direct" contact centres. Initially this will not entail any job losses, but potentially may affect about 500 jobs in the City as the department goes through a downsizing operation.

While the news initially looked bad, the Council and its partners will be making every effort to attract replacement jobs.

Derby has been actively pursuing civil service jobs that could be moving out of London, in response to the recent Lyons Report which suggests up to 20,000 jobs could relocate from London and the South East.

The building at Wyvern Business Park is a relatively new civil service relocation. We need to check in more detail on the actual job losses and the capacity it would leave at the Wyvern in terms of people and office space. The offices already have all the technology needed for civil service operations.

We hope the Government will make best use of the space already available to it in Derby and build on what is already there by relocating jobs to the city from London and the South East. As part of the process, we are working with our local MPs and will be discussing the DWP announcement with them.

The Council and its partners have already put forward proposals to the civil service in response to Lyons, highlighting the benefits of relocating to Derby and the East Midlands region."
