Local Government (Miscellaneous Provisions) Act 1976
Private Hire Vehicle Conditions
Condition 11 – Signs, Notices/Advertisements etc.

I act on behalf of Albatross Cars, 14A Midland Rd, Derby, DE1 2SN and have been asked to write to you regarding the signage displayed on the Derby licensed private hire vehicles working for their company.

Condition 11(i) of the Council's standard conditions states:

No Operator's company sign shall include the words "Taxi(s)" or "CABS" or the words "FOR HIRE" or any other words of a similar meaning or appearance likely to cause a person to believe the vehicle is a hackney carriage or is presently available for hire.

In addition, the Council also allows minimal advertising to private hire vehicles in accordance with condition 11(k), (I) & (m).

The reason for writing to you today is to request that the Council depart from their standard conditions in respect of the signage used by Albatross Cars. The signage as proposed would comply fully with conditions 11(k), (i) & (m) but not with condition 11(i).

I have attached a copy of the proposed signage for your attention which you will see uses the word "TAXI" within the advertising panel.

Should this matter be referred to the Licensing Committee for consideration, then we would ask that you notify us of the date when the matter will be considered so that we can attend and if requested to do so can answer questions in respect of this matter.
