'This Council notes the comments made by the judge in the recent election fraud case.

This Council calls on Derby Labour Party to fully co-operate with the police, to bring about the successful prosecution of all those others involved in the electoral fraud that took place in Arboretum Ward at the May 2012 elections.'

'This Council welcomes the additional Discretionary Housing Payment (DHP) funding made available by the Government since April 2013, designed to help people who are under occupying and fall into arrears. The Council notes that Derby Homes is already working closely with tenants to manage arrears resulting from under occupancy.

Other social housing tenants who are facing hardship as a result of under occupation charges may not have such accommodating landlords.

This Council therefore agrees to introduce a non eviction policy related to under occupation charges where the following criteria are met.

- where the tenant has applied for rehousing to remove under occupation
- where the tenant has applied for a DHP award
- where the tenant has maintained their tenancy effectively in terms of overall property condition and standards of behaviour.

Council proposes that once the tenant has applied for

rehousing and can bid for properties, they will also be offered properties to consider. If they refuse two reasonable offers to downsize they will no longer be protected by this policy. Furthermore Council calls upon the Coalition Government to follow expected Liberal Democrat policy, and excuse those who have registered to downsize from the under occupancy penalty.

Stockport Council has successfully implemented similar proposals.
