Licensing of Eight-Seater Private Hire Vehicles

Purpose

- 1.1 The report asks members to consider whether the current vehicle specification for private hire vehicles (attached at Appendix 1) requires amendment to allow consideration of vehicles which carry 8 passengers.
- 1.2 The option may appeal to customers travelling in a larger group.

Recommendation(s)

- 2.1 To agree that applications for vehicles which are required to be licensed for 8 passengers which do not meet the current vehicle specification for such vehicles are referred to the Licensing Sub-Committee for consideration.
- 2.2 To agree that the Head of Environmental Protection, Housing Standards, Licensing, Emergency Planning and Business Continuity and the Licensing Team Leader be delegated the power to amend the Council's adopted Specification for Private Hire Vehicles to incorporate the requirements for such changes.
- 2.3 That all other Council policies relating to Private Hire Vehicles shall apply to such vehicles.

Reasons

3.1 Licensing a wider range of vehicles with varying seat capacities means customers will have greater choice of vehicles to suit their needs, and also allow the proprietor the option of providing a service option which caters for larger numbers.

Supporting information

4.1 The Licensing Department has been approached to consider licensing vehicles which can carry a maximum of 8 passengers plus a driver.

- 4.2 Generally, most of the vehicles which are manufactured to carry 8 persons do not meet the Council's current vehicle specification, particularly in relation to the size of the additional front passenger seat and the close proximity of the passenger to the driver, for safety reasons.
- 4.3 Section 48 of the Local Government (Miscellaneous Provisions) Act 1976 states that:
 - 'a district may on receipt of an application from the proprietor of any vehicle for the grant in respect of such vehicle to use the vehicle as a private hire vehicle, grant in respect thereof a vehicle licence...' provided that certain criteria are met. One such criteria is that the vehicle must be 'suitable in type, size and design for use as a private hire vehicle'
- 4.4 Members may wish to also bear in mind that the definition of a Private Hire Vehicle is:

'A motor vehicle constructed or adapted to seat **fewer** than nine passengers, other that a Hackney Carriage or Public Service Vehicle which is provided for hire with the service of a driver for the purpose of carrying passengers.'

Specification For Private Hire Vehicles

Revised August 2019

(For vehicles designed to carry up to eight passengers)

			Implementation Date
1	A Private Hire vehicle shall not have an exterior body colour that is yellow, a shade of yellow or of which yellow or any shade of yellow may be a primary colour, such that the vehicle may resemble the approved colour for Hackney Carriages licensed by the Council. Any queries or disputes about the suitability of a vehicle colour will be determined by the Team Leader (Licensing)		
2	The	following vehicles will not be approved for licensing as Private	e Hire vehicles:
	•	any derivative of an LTI vehicle	
	•	any derivative of a Metrocab vehicle.	
3	The vehicle must be right-hand drive.		
4	а	The vehicle must have at least two bodyside doors for passengers excluding any rear door.	
	b	For vehicles with three or more rows of seats, rear seat passengers (all those seated behind the front row of seats) must have direct access to two doors.	
5	Access from the doors to the seats must be direct, without the necessity for folding or moving seats or parts of the seats to gain access.		
6	а	All seats must be forward or rear facing and adequate in size, shape and condition for passengers.	
	b	The vehicle shall be equipped at all times with seat belts of an acceptable type in respect of every seat which can be used for the carriage of passengers.

7	а	The vehicle must contain a separate lockable luggage compartment or have a secure screen or cage fitted to contain luggage within the vehicle.	
	b	The arrangements for storing luggage must not obstruct the use of exits from the vehicle.	19 January 2017

	a.	The spare wheel and tyre must be identical to the size of the four road wheels unless the vehicle's original manufacturer's specification includes provision of a space saver tyre, a run-flat tyre or a temporary seal & inflation gas product kit. The use of any space saver, run-flat tyre or temporary seal & inflation gas product must be for emergency purposes only. A space saver wheel, run-flat tyre or tyre containing a temporary seal & inflation gas product must be replaced with a full size wheel or new tyre at the earliest opportunity and in any event, immediately after the fare-paying journey, if any, during which it was fitted (as applicable) to the vehicle has been completed. Whilst a deflating run-flat tyre, space saver wheel or temporary seal & inflation gas product is in use, the driver must observe the vehicle manufacturer's recommendations in relation to its usage, in particular those relating to speed and loading. The vehicle proprietor and/or operator, as appropriate, must ensure that the driver is made aware of those recommendations.	22 August 2019
	b.	For the avoidance of doubt, use of a space saver wheel, a run-flat tyre or temporary seal & inflation gas product on a vehicle is solely at the discretion of the driver and the condition in paragraph 8.1 is not to be regarded as an instruction by the Council, to the driver, to use a space saver wheel, run-flat tyre or temporary seal & inflation gas product.	22 August 2019
9	а	The interior floor surface of the vehicle must be fitted with non-slip covering and any steps to the vehicle must be fitted with anti-slip treads.	
	b	Where vehicles are fitted with a door step, a step light must also be provided.	
10	(Co	vehicle must comply in all respects with the Motor Vehicle nstruction and Use) Regulations 1986 and all other relevant slation.	


11	а	The vehicle must satisfy the Director of Communities, Environment and Regulatory Services as to its fitness for use as a Private Hire vehicle upon full examination and testing to the standards of the MOT test and the Council's Supplementary Testing Manual.	
	b	The vehicle must at all times comply with Derby City Council's Private Hire Vehicle Licence Conditions.	
12	а	If any vehicle fails to meet only one of the dimension requirements (Item 16), the Director of Communities, Environment and Regulatory Services may still approve the vehicle to be licensed, but for reduced number of passengers.	
	b	If any vehicle fails to meet the dimension requirements due to special adaptations to assist the carrying of disabled passengers, the Director of Communities, Environment and Regulatory Services may still approve the vehicle for licensing.	
13	Any vehicle modified to use liquefied petroleum gas (LPG) as a fuel shall have all associated modifications carried out by an approved and certificated installer to the standards specified by the LPG installation manufacturer. The installation shall comply with Liquefied Petroleum Gas Association Code of Practice No. 11 – Autogas Installations, or to an equivalent standard accepted by the Council. The proprietor shall provide a Certificate of Safety that the vehicle complies with relevant Code of Practice on completion of the LPG installation.		
14	Any	LPG tank shall be located within the vehicle boot.	19 January 2017
15	Vehicles may be fitted with darkened glass at the discretion of the Operator. If providing a vehicle so equipped for a booking, the Operator shall ensure that the customer is given the option of accepting or rejecting the vehicle before the contract for hire is concluded. A record of the customer's response must be recorded in the booking details. For the avoidance of doubt, darkened glass means tinted glass, privacy glass and any proprietary film added to the windows.		
16		following minimum dimensions indicated in Figures 1, 2, 3 4 apply to all vehicles intended to be licensed as private	

hire vehicles. All seats fitted in a vehicle must comply with the following minimum dimensions: (please refer to the Description notes for guidance)	

17	Vehicle Modification	
	If the vehicle has being modified since leaving the manufacturer, a 'normal' level Voluntary Individual Vehicle Assessment must be carried out before presenting the vehicle at one of the Council approved testing stations	19 January 2017





