Each commission can conduct up to two topic reviews per year. At the time of writing the configuration of overview and scrutiny commissions for the municipal year 2005/06 is not known. However, the conducting of topic reviews will continue as a key – and rewarding - part of Derby's overview and scrutiny process. The Chair has asked Commission members for suggested review topics. Although a final decision would be taken at the June meeting, should the Community Regeneration Commission be re-appointed, initial consideration at the 10 May meeting allows the present Commission to submit suggestions to successor bodies.
