This would be a disaster for the City of Derby where real progress is being made in tackling crime and anti-social behaviour and will significantly impact on the excellent partnership working in the crime and disorder arena which is now paying real dividends to the people of this City.

#### Council there resolves to:

- 1. Request the Leader of the Council and the relevant Cabinet Member to make urgent representations to the Home Office to express Council's concern about the budgetary settlement and the threats it will pose to Derby and its Policing
- To make robust representations about the historic underfunding of Derbyshire Police with a view to gaining closer parity in Police numbers with those enjoyed by our East Midlands neighbouring Forces
- To fully support the Council's representatives on the Police Authority requiring them to oppose and resist any cuts to the Police establishment within the City of Derby."
- (4) Councillor Smalley to move, Councillor Willoughby to second:

"Council notes with concern the Government's proposals to seek to ratify what is now called an amending Treaty to the EU Constitution without first putting their decision forward for democratic scrutiny by the electorate of this city and this country. This proposed Treaty is, in all but name, a new EU Constitution, the effects of which will be felt by all the people of this city in one way or another.

Council considers that this is an issue which is too important to be decided by MP's alone and considers that the only legitimate mandate for agreeing to this new Treaty will be one that is obtained by means of a referendum.

Council therefore calls upon the Government to honour its Manifesto pledge from the last Election and to put this crucial issue to a national Referendum."

(5) Councillor Graves to move, Councillor Afzal to second:

"This Council is disappointed that further Post Office closures are being considered. Derby City Council urges the Post Office not to close any on its proposed list. These being in the City of Derby:

Abbey Street Ashbourne Road Mansfield Road Shelton Lock Pear Tree

## Wilmorton Derby

The withdrawal of these facilities will cause real difficulties in the neighbourhoods concerned.

Council calls upon the Leader of the Council to write to the Post Office and the Minister in the strongest possible terms."

(6) Councillor Care to move, Councillor Richards to second:

"Derby City Council is angry about the continuing threat of post office closures."

Post offices are key public service outlets in both rural and urban communities. Closing them results in hardship to individuals and small businesses."

Council condemns the government's current attitude to post offices. Removing government businesses from post offices and demanding specific numbers of post offices to close prevents effective running of the network by Post Office management."

Council therefore calls on the government to recognise the importance of local post offices and to review its policy on the Post Office to ensure that no further closures take place."

(7) Councillor Skelton to move, Councillor Allen to second:

"Council endorses the broad concept of 'extra care' to provide people with a consistent caring community into dependent old age.

Council further recognises that:

- 1. Derby currently has very few unoccupied residential care beds.
- The council's residential care homes are in a mixed state
  of repair. For example, Arthur Neal Home needs major
  maintenance or rebuilding, but Bramblebrook House has
  recently had new windows and is in good decorative
  order, meeting all registration standards.
- 3. The council owns further land close to Bramblebrook House, including Humbleton View, which is already scheduled for closure.
- 4. The current trend is to move specialist day care facilities into community settings.

Council therefore resolves to ask Council Cabinet to keep Bramblebrook House open.

Council further resolves to ask the Cabinet Member for Adult Services to explore the opportunities for providing extra-care type housing and other facilities on the Bramblebrook/Humbleton View site."

## 1. Duffield Road Bus Lanes

It was moved by Councillor Willoughby, and seconded, that the Council acknowledges that the trial Duffield Road Bus Lanes have not been popular with residents and road users.

The current configuration of narrow lanes is a potential health and safety hazard, and indeed there have been a number of accidents or near accidents as a result. The bus lanes have also resulted in an increase in traffic congestion, and hence carbon emissions, going into and out of the city.

The Council therefore calls upon the Cabinet Member for Planning and Transportation to immediately end this trial scheme, which has just been further extended for 1 year, and to return this section of Duffield Road to its original configuration for two lane traffic.

It was moved by Councillor Richards, and seconded, that the motion be amended by the deletion of the whole of the second paragraph and all words after the words "upon the" in the third paragraph, and the insertion of the words "some" between the words "with" and "residents" in the first paragraph, the words "some" between the words "and" and "road" in the first paragraph, and the words "Planning and Transportation Overview and Scrutiny Commission to carry out a detailed review of the Duffield Road Bus Lane as a matter of urgency, and to make recommendations to the Cabinet Member for Planning and Transportation" in the third paragraph.

(The effect of the amendment, if approved, was that the motion would read as follows:

"The Council acknowledges that the trial Duffield Road Bus Lanes have not been popular with some residents and some road users.

The Council therefore calls upon the Planning and Transportation Overview and Scrutiny Commission to carry out a detailed review on the Duffield Road Bus Lane as a matter of urgency, and to make recommendations to the Cabinet Member for Planning and Transportation.")

#### 2. Place names

- 9. To agree that £7m of capital receipts should be earmarked to enable a full refurbishment of the Council House to take place.
- 10. To agree that the total set aside for the remainder of the accommodation strategy should be increased from £10m to £25m, with the increase being funded from £4m of future potential capital receipts, £5.5m of self-financing prudential borrowing and £5.5m prudential borrowing within the Public Realm programme, including potential savings on rents.
- 11. To agree that allocations of potential Public Realm funding in future years should be determined according to the Council's corporate plans and priorities, subject to affordability within the revenue budget.
- 12. To confirm the process and timetable for taking decisions on the detailed content of the capital programme for 2008/9 to 2010/11, set out in Appendix 3.
