1. Ref: 204006 – Request for pedestrian crossing or central refuge, Boulton Lane – received 14.01.04

Issue

A member of the public thanked the Council for removing the speed humps in the Boulton Ward. She had not received any complaints about speeding along Boulton Lane. She had however received complaints from pedestrians trying to cross the road by the Co-op. She asked if the Council would consider putting a refuge in at the point.

Action reported at the meeting on 22 September 2004

It was reported that a new puffin crossing would be installed on Crayford Road near to the shops, when funds become available. This request was assessed too late to be considered in this year's works programme but will be considered for next year. This crossing may help to reduce the numbers of children crossing near to the Holbrook Road/Crayford Road/Bracknell Drive staggered crossroads. Provision of a crossing at this junction would be difficult without signalising the junction and a stand alone crossing installed away from the junction may be ignored by children. This location will be added to our list of investigations and an evaluation will be carried out during the next school term.

It was also noted that an assessment had been made regarding a crossing request on Boulton Lane/Maidstone Drive. A survey conducted in July showed this site did not meet the criteria for a crossing. Observations on site revealed that pedestrians were able to cross safely using suitable gaps in traffic.

Regarding Cllr Wynn's request for a school crossing patrol on Boulton Lane, the Council will investigate this during term time. Putting in a new crossing on Crayford Road may alter travel patterns. Since two of the four schools in the vicinity are senior schools a crossing patrol might not be well used even if one was provided.

Public response at the meeting on 22 September 2004

Thelma Bradshaw, resident informed the panel that she had received a letter from Ian Wallace, Projects Engineer, stating that although they are looking into the project, ultimately the safety of children on their way to school does lay with the parents. She was quite concerned about this reply.

Council response at the meeting on 22 September 2004

Bill Reed explained to the resident that the Council does in fact work with both parents and officers to deal with the issue of children's safety.

Issue

A member of the public raised concerns about the condition of the car park at the rear of Alvaston Library. There was a lack of lighting and many potholes on the car park.

3. Ref: 204032 Anti social behaviour, Allenton Recreation Ground - received 07.07.04

Issue

A member of the public raised concerns about antisocial behaviour, motorbikes, rubbish and graffiti on Allenton Recreation Ground

Action reported at the meeting on 22 September 2004

It was reported that the rubbish, mainly located around the Allen St entrance, had been removed. The Council has amended its maintenance regime so that grass is cut closer to the hedge bottoms reducing the long grass which is a rubbish trap.

The graffiti on the gable ends of the house on Allen Street is being investigated. It was reported that officers are trying to establish who owns these properties at the moment as it is the responsibility of the owners to remove the graffiti.

The Beat officer responsible for the Allenton area has investigated this issue and continues to monitor the recreation ground.

Public response at the meeting on 22 September 2004

Residents were pleased with the work, but reported that after just two days the bins were full of drinks bottles and cans.

Councillor Blanksby acknowledge that issues of drinking on the park have risen, and commented that this is a serious issue that needs to be looked at.

4. Ref: 204033 Road markings, Chellaston High Street - received 07.07.04

Issue

A member of the public asked if the white lines on High Street, Chellaston could be repainted

Action reported at the meeting on 22 September 2004

It was reported that there is already a white centre line on High Street that extends from the junction with the A514 to the roundabout at Fellowlands Way. Where the carriageway is particularly narrow a centre line is not used. The absence of a centre line is indicative of a narrow carriageway width and as such motorists are required to take care when meeting oncoming vehicles.

Public response at the meeting on 22 September 2004

Peter Robinson, local resident disagreed with the statement that there 'is' a white line – he stated that there 'was' a white line, but due to erosion, it has disappeared from view.

Bill Reed agreed to get the faded line reinstated.

Councillor Turner asked for confirmation on the original line, as to whether it should be there.

Issue

A resident requested that the area panel 2 meeting begin at 7 pm, to allow working people to attend. She was concerned that at the moment, with a start time of 6 pm, it is only attracting retired residents.

The resident stated that she had raised this issue at the last minute, but it had not been recorded in the minutes or update report.

Another resident commented that if it was held later, then retired / elderly people may not feel happy in attending.

Bill Reed explained that there had been a discussion with all area panels about an appropriate start time, and area panel 2 had chosen 6 pm.

6. Ref: 204038 - Grass on recreation ground, near St Stephen's Church - received 22.09.04

Issue

A local resident was concerned about the state of the grass cuttings – he explained that whoever was doing this work, did not know how to use the machinery correctly. The green, during the grass cutting season is ankle deep in cuttings, and some residents have fell over. It is extremely dangerous in wet conditions.

Action reported at the meeting on 22 September 2004

Public response at the meeting on 22 September 2004

He went on to explain that he has spoken and written to the Council, asking them to do something about this issue, but has been continually passed on to different people. This has been ongoing for 12 months, and he explained that if he does not receive a response, then he would take this up with both John Winters, and the Chief Executive. This is extremely dangerous, particularly in wet conditions.

Another resident explained that it is the Council's policy not to collect cuttings, and this is a problem throughout the City. She asked that relevant officers attend a panel meeting.

Council response at the meeting on 22 September 2004

Actions agreed at the meeting on 22 September 2004

Bill Reed agreed to respond to the resident with regard to the grass cuttings.

Updates on agreed actions to feedback to the meeting on 3 November 2004

The grass will now be cut twice more before the end of the growing season. The cuts will be fortnightly, thus the grass will be mown on or around 13 and 27 October. The grass is cut by contractors acting on behalf of the Council.

It has now been arranged that on a day shortly after the grass is cut, the Council's mechanical sweeper will visit the recreation ground and sweep the paths. This will ensure that the paths are free of grass and other refuse which would cause them to be potentially dangerous. The sweeping will not take place necessarily on the same day or the following day after the cut, as weather might delay the cutting and this will prevent the unhelpful occurrence of the path being swept shortly before the grass is cut. Accumulations of grass which have hardened over the summer will be removed.

9. Ref: 204007 - Petition, High volume of traffic using A514 - received 14.01.04

Issue

A petition was received suggesting that traffic volumes on the A514 were excessive and asking for action to be taken.

Action reported at the meeting on 22 September 2004

It was reported that the Highways Agency report was not available yet. However, preliminary findings show a reduction in traffic on roads in Alvaston but Officers are awaiting more details findings.

Route signing takes into account the nature and function of a road, with traffic being directed along the most direct and suitable route. The A514 is part of the Primary Route Network as is the A6. Alternative signing for HGVs would only be put in place if there were a weight limit or a height restriction in place along the route. Each request for a weight restriction would be investigated and judged on its own merit. There are already a number of weight restrictions covering the City while leaving a framework of main traffic routes. All traffic that has to access a site within one of the restrictions is exempt from that restriction however HGV traffic not gaining access is restricted from entering. As with all traffic regulation orders if there are no physical measures to ensure the order is adhered to, it relies on enforcement. We have to make sure that access is maintained throughout the City whilst encouraging use of the most suitable routes. It was noted that a letter has been written to Mr Howarth.

The former canal bridge on the A514 exhibits some cracking, this not indicative of any danger or deficiency in carrying capacity. Strength calculations were undertaken in 1999 and our assessment was that the bridge can carry 40 tonnes without difficulty. The bridge was inspected again in August 2003.

Public response at the meeting on 22 September 2004

A member of the public explained that he was delighted with the news from Councillor Leeming, but could not believe that this could not be done on the A514, when it was done some years ago on the A52 to stop lorries coming into the centre of derby. If they can do it there, then it should be done on A50 / A514. He stated that the A52 when done, was also a trunk road at the time.

Council response at the meeting on 22 September 2004

Councillor Wynn referred to page three of the minutes regarding section 106 funds, and whether it could be used. He explained that he still not had a reply.

Bill Reed apologised for this, an explained that the residential development that has been approved – West Chellaston – subject to 106, the developers need to make a contribution over a period of ten years, towards the work on the A514. This will be determined by both the developers and the Council. He further explained, that as yet, no decision had been made as to when the fund would be available and how it would be spent.

Councillor Wynn also asked that the meeting be informed once a decision about the funding is known.

Councillor Leeming reported that at a previous meeting, himself and Councillor Tittley had raised the issue of 44tonne lorries using this route. Since then, he has spoken to Lucy Care, who assured him there will be a 7.5 tonne limit on the Shardlow Road, from the Blue Peter.

Area panel 2 update report - for 3 November 2004

David Gartside explained that the Council have to accommodate HGVs coming into the city, and must make sure that they are on the most suitable routes. The A514 is not a trunk road, but a principal road. He explained that HGVs would be entitled to use this route for access even if a weight restriction is introduced.

Councillor Bayliss requested that a full report be brought to the next panel meeting describing the various types of roads, and the locations of them within area panel 2. This was welcomed by panel members.

10. Ref: 204026 – Petition, Installation of bus shelters – Wragley Way and Deepdale Avenue - received 05.05.04

Issue

A petition was received requesting the installation of a bus shelter on Wragley Way and Deepdale Avenue.

Action reported at the meeting on 22 September 2004

A separate report was available at the meeting. There is now a revised petition – is it possible to create a bus shelter on Wragley Way and Deepdale Lane. This has been opposed by residents – therefore wragley way has been removed from the programme. A location on Deepdale Lane has been identified, and it has been put forward into the local transport plan for funding.

Public response at the meeting on 22 September 2004

A local resident was concerned that his issue that was raised at the last meeting did not appear in the report. He had suggested that the bus stop outside Sinfin Community School, which is very rarely used, be moved around the corner to the site opposite Heath Court. As there are a lot of elderly people around there, this would be an ideal spot. If this happened, there would only be removal costs associated with it.

Council response at the meeting on 22 September 2004

Bill Reed apologised that the response had not been as comprehensive, and explained that most of the costs associated with bus shelters are not actually above ground, but involve the digging in. He confirmed that this location would be noted and put forward.

Councillor Bayliss requested that the costs of moving the shelter are looked into, as there may be a possibility that the area panel budget could fund this.

Actions agreed at the meeting on 22 September 2004

To provide costs of moving the bus shelter from outside the school to Heath Court.

Updates on agreed actions to feedback to the meeting on 3 November 2004

Moving shelters is not straightforward, and usually nearly as expensive as providing a new one.

The site mentioned opposite Heath Court between the crossing and the roundabout is on the list for a new shelter. We will be finalizing priority soon, subject to funding, we expect this shelter to be implemented during the next year financial year.
