Recommendations from Overview and Scrutiny Boards

SUMMARY

- 1.1 Overview and scrutiny boards routinely conduct service reviews to support the Council Cabinet in policy development. The Corporate Scrutiny and Climate Change Board and the Children and Young People Board have conducted topic reviews in areas that fall within their respective remits and agreed their respective reports (attached).
- 1.2 The Corporate Scrutiny and Climate Change Board carried out a review of challenging regeneration sites in and around the city centre whilst the Children and Young People Board looked at whether our children's homes are fit for purpose now and in the future? In both reviews, members held additional special meetings and received evidence from wide range of stakeholders to form their recommendations.

3.1 Overview and Scrutiny Boards have a role in assisting the Council and the Council Cabinet in developing the budget and policy framework, by conducting in-depth analysis of policy issues. Corporate Scrutiny and Climate Change Board and the Children and Young People Board have conducted reviews in service areas that fall within their respective portfolios and their reports are submitted for consideration by the Council Cabinet.

SUPPORTING INFORMATION

Corporate Scrutiny and Climate Change Board

4.1 The Corporate Scrutiny and Climate Change Board conducted a detailed review on difficult to regenerate sites in the city centre. In conducting this review members received evidence from a range of individuals including senior members and officers as well as developers with significant interests in the city. The review focused on three major sites in the city including Friar Gate Goods Yard, Becketwell and Castleward urban village. The Board has a made a number of recommendations which will help to move these sites forward.

Children and Young People Board Recommendation

- 4.2 The Children and Young People resolved at its meeting on 11 September 2012 to conduct a topic review to establish 'Are our children's homes fit for purpose now and in the future?'
- 4.3 Councillors Whitby and Bailey formed a review team and heard evidence from witnesses, visited Children's homes and attended the Children in Care Council. Background evidence including information from Ofsted, examples of best practice and relevant policies and strategies was also explored.
